Commissioner Lee suggested reaching out to the members of the pickleball group from his event as potential presenters.

Commissioner Dryan-Zagala was interested in reaching out to the City's HR department to learn more about disability employment data.

Commissioner Krick proposed a program where kids, seniors, or other members of the community would be able to repair and keep bicycles confiscated by RPD, as a way of both teaching useful skills and providing a form of transportation.

Vice Chair Stuart would like more information on City Staff dedicated to outreach with the disabled community. She would like someone whose job is to manage a calendar of events, and to help with collaboration, correspondence, and accountability.
