DISCUSSION CALENDAR

FISCAL YEAR 2025-26 ANNUAL PURCHASE ORDERS - CONTINUED FROM JUNE 10, 2025 The City Council received a report regarding the annual purchase orders for Central Stores for an estimated total of \$23,768,60, and not-to-exceed 20 percent allowance for Producer Price Index (PPI) increases for Fiscal Year 2025-26 annual purchase orders for Central Stores. No one spoke on the matter.

Following discussion, it was moved by Councilmember Robillard and seconded by Councilmember Hemenway to (1) approve Central Stores Annual Purchase Orders for an estimated total of \$23,768,660 for Fiscal Year 2025-26; and (2) approve and not-to-exceed percent allowance for Producer Price Index (PPI) increases for the Fiscal Year 2025-26 Annual Purchase Orders for Central Stores; and (3) authorize the City Manager, or his designee, to award the purchase orders for such procurements for the items designated. The motion carried unanimously with Councilmembers and Perry absent.

Councilmember Perry arrived during the following item.

MODIFY SUPPLEMENTAL SENIOR RENTAL ASSISTANCE PROGRAM - INTERFUND TRANSFER The City Council received a report to remove Section 8 waitlist participants requirement, assist mobile home owners with space rental assistance, and assist seniors in shelters with rental assistance. Five people spoke on the matter.

Following discussion, it was moved by Councilmember Cervantes and seconded by Councilmembers Perry to (1) approve modifying the Supplemental Senior Rental Assistance Program to remove the Section 8 waitlist participants requirement, assist mobile home owners with space rental assistance and assist seniors in shelters with rental assistance; and (2) authorize the Chief Financial Officer, or his designee to record an interfund transfer and supplemental appropriation in the amount of \$100,000 from the Measure Z Fund, Homeless Outreach account to the Measure Z Capital Fund, 23/24 Riverside Access Center Rehabilitation project account. The motion carried unanimously.

No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Robillard and seconded by Councilmember Conder to (1) introduce an ordinance amending the Riverside Municipal Code (RMC) Chapter 3.30 Section 3.30.030 - Schedule of Regulation, Products and Services, adding one fee; and (2) adopt a resolution approving the Proposed Fiscal Year 2025-26 Master Fees and Charges Schedule; and (3) authorize the Chief Financial Officer, or designee, to record an increase to the General Fund, Public Works City Engineering Services, Plan Check Expedited Revenue account in the amount of \$200,000 and appropriate expenditures in the same amount to the General Fund, Public Works Enaineerina Services. Professional Services Citv Plan Check account for Fiscal Year 2025-26 and ongoing. The motion carried unanimously.

Determine project is exempt from further California Environmental Quality Review pursuant to Section 15061(b)(3) (General Rule), as can be seen with certainty the project will not have an effect on the environment. No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Falcone and seconded by Councilmember Robillard to (1) determine that Planning Case PR-2025-001768 (Zoning Text Amendment) is exempt from further California Environmental Quality Review pursuant to Section 15061(b)(3) (General Rule), as it can be seen with certainty that approval of the project will not have an effect on the environment; and (2) approve Planning Case PR-2025-001768 (Zoning Text Amendment) based on the findings summarized in the Planning Commission Staff Report; and (3) introduce an Ordinance amending Title 19 (Zoning) of the Riverside Municipal Code. The motion carried with Councilmembers Falcone, Cervantes, Robillard, Mill, Perry and Hemenway voting aye and Councilmember Conder voting nay.

CITY SPIRIT AWARD

Mayor Lock Dawson presented the 2024 City Spirit Award to Richard Roth for his extraordinary deeds, community spirit, citizenship, and dedication to enhancing the quality of life in the City of Riverside.

CONSENT CALENDAR

It was moved by Councilmember Hemenway and seconded by Councilmember Perry to approve the Consent Calendar as presented affirming the actions appropriate to each item, with the exception of the Request for Proposal for agreement for landscape maintenance services for neighborhood parks to be removed from the Consent Calendar for separate discussion. The motion carried unanimously with Councilmember Cervantes absent.

INCREASE FISCAL YEAR 2024-2025 LEGAL BUDGET - ELECTRIC UTILITY COSTS - FEDERAL ENERGY REGULATORY COMMISSION ("FERC") PROCEEDINGS

The City Council approved (1) an increase in the annual legal budget for Fiscal Year 2024-2025 for the law firm of Thompson Coburn in an amount not-to-exceed \$72,000 for a total revised budget of \$792,000; and (2) the annual legal budget for Fiscal Year 2025-2026 for the law firm of Thompson Coburn in an amount not-to-exceed \$792,000.

INCREASE LEGAL BUDGET - LITIGATED EMINENT DOMAIN CASES

The City Council approved an increase to the legal budget for the law firm of Shute, Mihaly & Weinberger, LLP, in an amount not-to-exceed \$183,750 for a revised total budget of \$208,750 for outside counsel to consult on litigated Eminent Domain cases related to Third Street Grade Separation Project.

LEGAL BUDGET - SPECIALIZED LEGAL ASSISTANCE

The City Council (1) approved a legal budget for the law firm of Jarvis Fay in the amount not-to-exceed \$70,000, to defend the City in the appellate case entitled Regents of the University of California v. City of Riverside, an appeal to a writ of mandate action challenging the City's sewer capacity fees, in which the City prevailed; and (2) authorized the City Attorney to execute an engagement letter to retain Jarvis Fay to

AGREEMENT - RIVERSIDE ADVENTURE CENTER AND MIXED-USE TOWN CENTER DEVELOPMENT PROJECT

The City Council (1) approved a Professional Consultant Services Agreement for Albert A. Webb Associates for preparation of the California Environmental Quality Act (CEQA) environmental review for the proposed Riverside Adventure Center and Mixed-Use Town Center Development project for an amount of \$299,492; (2) authorized a 40 percent contingency in the amount of \$114,829 resulting in a contract amount not-to-exceed \$414,321; and (3) authorized the City Manager, or his designee, to execute the Professional Consultant Services Agreement with Albert A. Webb Associates, including making minor and nonsubstantive changes including but not limited to extensions to the term of the Agreement.

AGREEMENT - CONVEYANCE OF PROPERTY - TEMPORARY CONSTRUCTION EASEMENT The City Council (1) approved the Agreement for Conveyance of Property for the sale of a partial fee simple interest and a sixty-month temporary construction easement on a portion of City owned vacant land, identified as Assessor's Parcel Number 0276-122-06, located on the East side of Mt. Vernon Avenue on the South side of the Union Pacific Rail Line in the City of Colton; and (2) authorized the City Manager, or his designee, to execute the Agreement with the City of Colton, including making minor and nonsubstantive changes, and to sign all documents necessary to complete the transaction.

ANNUAL APPROPRIATIONS LIMIT - FISCAL YEAR 2025-2026 - RESOLUTION

The City Council adopted a Resolution establishing the Fiscal Year 2025-26 Appropriations Limit of \$465,304,960 as required by Article XIIIB of the State Constitution; whereupon, the title having been read and further reading waived, Resolution No. 24275 of the City Council of the City of Riverside, California, Establishing the Appropriations Limit for Fiscal Year 2025-2026 for the City of Riverside in Accordance With the Provisions of Division 9 of Title 1 of the Government Code of the State of California, was presented and adopted.

INSURANCE POLICIES RENEWAL

The City Council (1) approved the annual renewal of the City's various insurance policies negotiated through the City's Insurance Broker, Keenan & Associates, as outlined in the staff report, for a one-year term beginning July 1, 2025, and ending June 30, 2026, for an amount not-to-exceed \$9,825,218; (2) authorized a 15 percent contingency of \$1,473,783 for potential changes and coverage enhancements for a total amount not to exceed \$11,299,001; and (3) authorized the City Manager, or his designee, to execute all necessary documents submitted by Keenan & Associates to renew the City's various insurance policies, as outlined in the staff report, for the total amount not-to-exceed \$11,299,00, including making minor and non-substantive changes to the insurance documents.

PURCHASE - RIZON ELECTRIC COE CHASSIS WITH STAKE BED TRUCK

The City Council (1) approved the purchase of one Rizon Electric COE Chassis with Stake Bed – CLI 13 18L Chassis 18L from California State Bid 1-23-23-22A, for Central Stores through Los Angeles Truck Center, LLC, in the total amount of \$157,705.50; (2) authorized the Finance Department, in coordination with the General Services Department, to procure a comparable vehicle with equivalent specifications and pricing, in the event the originally specified unit is unavailable at the time of order, pursuant to the terms of the applicable statewide contract; and (3) authorized the City Manager, or designee, to execute the Purchase Order, including making minor and non-substantive changes.

AWARD BID 8163 - 2025 FORD F150 XL 2-WHEEL-DRIVE SUPERCABS - SUPPLEMENTAL APPROPRIATION

The City Council (1) awarded Bid 8163 to Fritts Ford, Riverside, for the purchase of eleven 2025 Ford F150 XL 2-Wheel-Drive SuperCabs for the Riverside Public Utilities Department, Water Operations Section for a total amount of \$566,617.30; (2) authorized the Chief Financial Officer, or designee, to record a supplemental appropriation in the amount of \$360,693.48 in the Central Garage Fund, Motor Pool, Automotive Equipment account; and (3) authorized the City Manager or designee to execute any purchase orders, agreements, and other documents necessary to effectuate this agreement, making any minor and nonsubstantive changes.

SERVICES AGREEMENT - REPAIR AND SERVICE OF VARIOUS CITY FUEL SYSTEMS

The City Council (1) approved a Services Agreement with Fuel Equipment Services Inc., dba Fuel Serv, Montclair, for repair and service of various fuel systems located at 8095 Lincoln and 5961 Acorn, in the amount of \$450,000 and with one optional two-year

extension; (2) authorized 20 percent change order authority for unforeseen repairs and services in the amount of \$90,000; and (3) authorized the City Manager, or designee, to execute all documents necessary to effectuate this agreement, including making minor and non-substantive changes, and to execute the optional two-year extension provided that the amount is included within subsequent approved budgets.

CHANGE ORDER - 2025 FORD F-150 XL 2WD SUPERCAB VEHICLES

The City Council (1) approved a change order in the amount of \$93,247.28 to Purchase Order 253783 for the purchase of two additional 2025 Ford F-150 XL 2WD SuperCab vehicles under Bid 8157, from Fritts Ford, Riverside, for the City of Riverside Public Works Department, Urban Forestry and Landscape Division, for a total purchase order amount of \$139,870.92; and (2) authorized the City Manager, or designee, to execute a change order with Fritts Ford, Riverside, to Purchase Order 253783.

MEMORANDA OF UNDERSTANDING - FRINGE BENEFITS AND SALARY PLAN - RESOLUTION The City Council (1) approved the Memorandum of Understanding (MOU) with the IBEW Local 47 Wastewater unit effective July 1, 2025, through June 30, 2028, which incorporate the negotiated salaries, benefits and other working conditions, and authorized the City Manager, or designee, to execute the Memorandum of Understanding on behalf of the City; (2) adopted the resolution amending the Master Fringe Benefits and Salary Plan to reflect the new MOU provisions for IBEW-Wastewater employees as outlined in Exhibit A and Exhibit B of the staff report; and (3) authorized the Chief Financial Officer or designee to record supplemental appropriations in the approximate amounts of \$267,222 in Fiscal Year 2025-26, \$438,263 in Fiscal Year 2026-27 and \$610,354 in Fiscal Year 2027-28 in the applicable accounts.

Whereupon, the title having been read and further reading waived, Resolution No. 24276 of the City Council of the City of Riverside, California amending Resolution No. 21052 to Amend Parts I, II, III, and IV of the Fringe Benefits and Salary Plan, to Reflect Various Updates and Changes in Connection with the Memorandum of Understanding with the International Brotherhood of Electrical Workers (IBEW) Local 47 - Wastewater Unit, was presented and adopted.

AGREEMENTS - ANNUAL SERVICE RENEWAL - SOFTWARE AND HARDWARE MAINTENANCE AND SUPPORT

The City Council (1) approved the annual renewal of services provided through 58 existing annual software and hardware maintenance and support or subscription

agreements for Fiscal Year 2025-26, where each agreement has aggregate expenditures in excess of \$100,000 over the life of the agreement, or will be surpassing \$100,000, for an estimated total amount of \$6,222,014; (2) approved a 15 percent change order authority for the renewals listed in in the staff report for Fiscal Year 2025-26, to be used if quotes are higher than expected, and/or for the use of minor supplemental purchases; and (3) authorized the City Manager, or designee, to execute all necessary documents for items listed in the staff report, including, but not limited to, renewals, purchase orders, change orders, agreements, amendments, and other minor non-substantive changes.

FUNDS ACCEPTANCE - TRAIL REPAIR AND LAND MANAGEMENT EQUIPMENT - SYCAMORE CANYON PARK RESERVES - SUPPLEMENTAL APPROPRIATION

The City Council (1) accepted \$121,486.35 from the Riverside County Habitat Conservation Agency for equipment purchases to be used for trail repair and land management purposes, including invasive species removal which will directly improve habitat for Stephens' Kangaroo Rat and other native species within the reserve; and (2) authorized the Chief Financial Officer, or designee, to record an increase in revenue in the amount of \$121,486.35, and appropriate an equal amount in the Grants and Restricted Programs Fund, Sycamore Canyon SKR Endowment Revenue and Expenditure accounts.

REJECT BID - FAIRMOUNT PARK TREE REMOVALS - WILDLIFE FUEL REDUCTION PROJECT The City Council (1) rejected bid submitted by Julian Tree Care, Inc., as nonresponsive and award Bid 8142 to Bay Area Tree Specialists, San Jose, in the amount of \$395,613.50 for the Fairmount Park Tree Removals for the Wildlife Fuel Reduction Project; (2) authorized 10 percent change order authority in an amount up to \$39,561.35 for project changes including, but not limited to, unforeseen conditions or necessary changes and an additional amount of \$19,780.67 for permit fees, for a total contract amount not-toexceed \$454,955.52; and (3) authorized the City Manager, or designee, to execute a Service Agreement with Bay Area Tree Specialists, including making minor and nonsubstantive changes.

AGREEMENT AMENDMENT - NATI FUENTES CENTRO DE NIÑOS CHILDCARE CENTER The City Council (1) approved the Fifth Amendment to the Lease Agreement with Concilio Child Development Centers, with total monthly rent of \$2,726.11 for an additional one-year period through June 30, 2026; and (2) authorized the City Manager, or designee, to execute the Fifth Amendment to the Lease Agreement with Concilio Child Development Centers, including making minor and nonsubstantive changes.

The City Council approved the Riverside Public Utilities 2025 Wildfire Mitigation Plan for submittal to the Wildfire Safety Advisory Board in accordance with California Public Utilities Code Section 8387.

TIMED PARKING ZONE REVISIONS - MARKET/SECOND - RESOLUTION

PUBLIC HEARING

PR-2024-001656 (TM) - APPEAL - WARMINGTON RESIDENTIAL - SUBDIVIDE 9.91-ACRE PARCEL INTO 49 SINGLE FAMILY LOTS - LA SIERRA/VICTORIA

Public hearing was called to consider an appeal, requested by Matthew Esquivel of Warmington Residential, of the Planning Commission's denial of a Tentative Tract Map to subdivide a 9.91-acre project site into 49 single family lots to facilitate a residential development of 46 market rate dwellings and 3 affordable dwellings. Thirty-one people spoke on the matter. The public hearing was officially closed.

The Mayor and City Council recessed at 8:29 p.m. and reconvened at 8:35 p.m. with Mayor Lock Dawson presiding and all Councilmembers present.

Following discussion, it was move by Councilmember Falcone and seconded by Councilmember Robillard to (1) uphold the applicants appeal of the Planning Commission determination; (2) determine that the proposed project is exempt from additional environmental review pursuant to Section 15183 and requires no new environmental analysis pursuant to Section 15168 of the California Environmental Quality Act (CEQA) Guidelines as the project is consistent with the General Plan 2025 Programmatic Environmental Impact Report, approved in November 2007, and its addendums. Based on the checklist prepared pursuant to CEQA Guidelines Section 15168, the proposed project is within the scope of the General Plan 2025 Programmatic Environmental Impact Report and its addendums adequately describe the proposed project for the purposes of CEQA; (3) approve Planning Case PR-2024-001656 (Tentative Tract Map) based on the findings outlined in the staff report and summarized in the findings and subject to the recommended conditions; and (4) include as part of the conditions of approval to complete the trail modifications keeping the enclosed eaves and that support traffic calming measures.
