2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AUTHORIZING THE SUBMISSION
4 OF APPLICATION AND ACCEPTANCE OF GRANT AWARD
5 FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY
6 THROUGH THE CALIFORNIA GOVERNOR’S OFFICE OF
7 EMERGENCY SERVICES FOR THE FISCAL YEAR 2023-2024
8 EMERGENCY MANAGEMENT PERFORMANCE GRANT
9 PROGRAM AND AUTHORIZING THE EXECUTION OF ALL
10 REQUIRED DOCUMENTS BY THE CITY MANAGER, OR HIS
11 DESIGNEE; AND AMENDING THE BUDGET FOR FISCAL
12 YEAR 2023-2024 ACCORDINGLY.

13 WHEREAS, the U.S. Department of Homeland Security (the “Grantor”) has been delegated
14 authority to award federal financial assistance for the Fiscal Year 2023-2024 Emergency
15 Management Performance Grant Program; and

16 WHEREAS, said federal funds have been sub-granted to the California Governor’s Office of
17 Emergency Services (“CalOES”); and

18 WHEREAS, the County of Riverside is the designated Operational Area to which CalOES
19 grant funds are awarded and distributed; and

20 WHEREAS, the City desires to apply for and upon grant award, accept the grant award from
21 the Department of Homeland Security in the amount of Sixty-Two Thousand Three Hundred Ninety-
22 Four Dollars (\$62,394); and

23 WHEREAS, the City Council desires to amend the annual budget of the City to reflect and
24 incorporate the grant so awarded to the City, and to increase the annual appropriations and
25 expenditures in the appropriate City program to reflect such award.

26 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
27 California, as follows:

28 Section 1: The City Manager, or his designee, are hereby authorized to submit a grant
application for and on behalf of the City of Riverside, through the County of Riverside, and is
hereby authorized to execute all actions necessary for the purpose of obtaining federal financial
assistance provided by the United States Department of Homeland Security and sub-granted through
the State of California, including any extensions and amendments thereof.

1 Section 2: The City Council of the City of Riverside hereby agrees to, and by this Resolution
 2 does, accept the Grant funds in the amount of Sixty-Two Thousand Three Hundred Ninety-Four
 3 Dollars (\$62,394) awarded to the City of Riverside, and authorize the City Manager or designee to
 4 accept any additional funds awarded pursuant to the 2023-2024 Emergency Management
 5 Performance Grant Program.

6 Section 3: The City of Riverside hereby agrees to comply with each and all of the terms,
 7 conditions, and limitations, imposed by the Grantor upon said Grant, and the City of Riverside City
 8 Manager, or his designee, are hereby authorized and directed to execute the Signature Authority
 9 documents as well as any agreements, assurance, or other documents as may be necessary in
 10 connection with acceptance and implementation of said Grant as may be required by the Grantor.

11 Section 4: The annual budget of the City of Riverside for fiscal year 2023-2024 is hereby
 12 amended by increasing the appropriations and authorized expenditures in such amount as is equal to
 13 the amount of Grant funds to be received by the City.
