### DISCUSSION CALENDAR

#### ABSENCE

It was moved by Commissioner Hutchins and seconded by Commissioner Benavidez to excuse the Absence of Commissioner Weinrich from the April 10, 2025, meeting. The motion was carried unanimously with Commissioner Holley absent.

Chair Williams requested that the Monetary Support to nonprofit organizations item be moved as the second item of discussion.

#### MONETARY SUPPORT TO NONPROFIT ORGANIZATIONS

Following discussion, it was moved by Vice Chair Vandenberg **and seconded by Commissioner Scott-Coe** that the Budget Engagement Commission recommend; (1) the inclusion of a dedicated five hundred-thousand-dollar line item in the Measure Z budget to fund nonprofit organizations that provide youth focused services aimed at prevention, early intervention, and long-term community wellbeing; (a) to be awarded annually by a competitive grant process with eligibility limited to nonprofits serving Riverside youth; (b) each recipient would enter into an agreement with the city outlining their use of funds, expected outcomes and; (c) a requirement to submit an annual report measuring their impact continued funding would be based on demonstrated effectiveness in alignment with the city's goals especially in the area of homelessness prevention. ~~Motion failed due to lack of a second.~~

Following further discussion, Commissioner Hutchins provided a substitute motion, seconded by Commissioner Ward to consider the creation of a subcommittee to discuss the creation of a new line item in Measure Z for youth homeless prevention and to review the current Measure Z item geared to members with disabilities. The motion was carried with Chair Williams, Commissioners Benavidez, Weinrich, Hutchins, Bello, Ward, Thomas, and Langner, voting aye, and Vice Chair Vandenberg, Commissioner Wroten and Scott-Coe voting nay, and Commissioner Holley absent.

During the following item, Commissioner Thomas stepped away and the meeting was paused while quorum was reestablished.
