

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ESTABLISHING THE APPROPRIATIONS LIMIT FOR FISCAL YEAR 2023-2024 FOR THE CITY OF RIVERSIDE IN ACCORDANCE WITH THE PROVISIONS OF DIVISION 9 OF TITLE 1 OF THE GOVERNMENT CODE OF THE STATE OF CALIFORNIA.

WHEREAS Article XIII B of the Constitution of the State of California as proposed by the Initiative Measure approved by the people at the special statewide election held on November 6, 1979, as amended by Proposition 111 approved on June 5, 1990, and operative July 1, 1990, provides that the total annual appropriations subject to limitation of each local government shall not exceed the appropriations limit of such entity for the prior year adjusted for the change in the cost of living and the change in population except as otherwise specially provided for in said Article; and

WHEREAS the State Legislature added Division 9 (commencing with Section 7900) to Title 1 of the Government Code of the State of California to implement Article XIII B of the California Constitution; and

WHEREAS Section 7902(b) of the Government Code sets forth the method for determining the appropriations limit for each local jurisdiction; and

WHEREAS Section 7910 of the Government Code provides that each year the governing body of each local jurisdiction shall, by resolution, establish its appropriations limit and make other necessary determinations for the following fiscal year pursuant to Article XIII B at a regularly scheduled meeting or a noticed special meeting; and

WHEREAS Section 7910 also requires that for fifteen (15) days prior to such adoption of the resolution, the records and documentation used to determine the appropriations limit and other necessary determinations shall be made available to the public for viewing; and

WHEREAS the City Council of the City of Riverside wishes to establish the appropriations limit for fiscal year 2023-2024 for the City of Riverside in accordance with the provisions of Article XIII B of the Constitution and Sections 7900, *et seq.*, of the Government Code.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,

1	California, as follows, that:
2	Section 1: It is hereby found and determined that the documentation used in the
3	determination of the appropriations limit and any other necessary determinations for the City of
4	Riverside for fiscal year 2023-2024 was available to the public in the Finance Department of said
5	City at least fifteen (15) days prior to the date of adoption of this resolution.
6	Section 2: The CITY Council of the City of Riverside elects to use the change in
7	California per capita income as the cost-of-living adjustment factor and the annual population
8	change for the City of Riverside as the population adjustment factor.
9	Section 3: The City reserves the right to adjust or amend the appropriations limit based
10	upon the use of alternative growth factors as authorized by Proposition 111 if such changes or
11	revisions would result in a more advantageous appropriations limit, now or in the future.
12	Section 4: The appropriations limit of the City of Riverside for fiscal year 2023-2024,
13	as established in accordance with Sections 7902(b) and 7910 of the California Government Code,
14	shall be \$413,103.814.00.
