

The City Council designated Councilmember Mill as the voting delegate and Councilmember Robillard as alternate for the Annual Business meeting of the 2024 League of California Cities Annual Conference and Expo held at the Long Beach Convention Center in Long Beach, October 16-18, 2024.

REQUEST FOR PROPOSAL 2374 - AGREEMENT - RECORDS STORAGE AND DESTRUCTION SERVICES

The City Council (1) approved the Services Agreement with Certified Records Management, LLC, in accordance with Request for Proposal 2374, for records off-site storage, retrieval, and destruction services through June 30, 2029, for an amount not-to-exceed \$60,000 annually and with a one five-year extension option for a not-to-exceed total of ten years; and (2) authorized the City Manager or his designee to execute the agreement and any future amendments relating to this award including making any non-substantive changes to the agreement with concurrence from the City Clerk.

MOBILE FOOD VENDORS VEHICLE PARKING RESTRICTIONS AMENDMENT - ORDINANCE INTRODUCED

The City Council approved the Land Use Committee recommendation to adopt the proposed Riverside Municipal Code amendment regarding mobile vending vehicle parking restrictions near commercial, industrial, and residential driveways; an Ordinance entitled "An Ordinance of the City of Riverside, California, Amending Chapter 5.36 to the Riverside Municipal Code Regarding the Regulation of Mobile Food Vendors, was presented and introduced.

AGREEMENT AMENDMENT - ADDITIONAL ADVISORY SERVICES - REVISED DEVELOPMENT PROGRAM - RIVERSIDE ALIVE PROJECT

The City Council (1) approved the Third Amendment to Professional Consultant Services Agreement with HR&A Advisors, Inc., to reinstate and extend the term of the agreement until December 31, 2024, to have the Consultant provide additional advisory services to evaluate a revised development program and parking arrangement and the associated fiscal impact for the Riverside Alive Project; and to add increased compensation not-to-exceed \$50,000, for a total agreement amount of \$385,000; and (2) authorized the City Manager, or his designee, to execute the Third Amendment to Professional Consultant Services Agreement with HR&A Advisors, Inc., including making minor and non-substantive changes.

CASE PR-2022-001359 - GENERAL PLAN AMENDMENT - MULTIFAMILY DEVELOPMENT RESIDENTIAL UNITS (FORMER KMART BUILDING) - 375 ALESSANDRO - MISSION GROVE/MISSION VILLAGE - SCHEDULE A PUBLIC HEARING

The City Council (1) scheduled a public hearing for December 3, 2024, for consideration of the Airport Land Use Committee (ALUC) overrule for Planning Case PR-2022-001359 General Plan Amendment, Specific Plan Amendment, Rezone, Tentative Parcel Map, Design Review, and Environmental Impact Report; and (2) reviewed the draft resolution and directed staff to provide a copy of the proposed decision and findings to both ALUC and the California Division of Aeronautics, a minimum of 45 days prior to the public hearing, whether or not to overrule ALUC.



The City Council (1) awarded Bid 8082 to WCM & Associates, Inc., Yucaipa, in the amount of \$799,000 for the labor, equipment and materials for the removal and replacement of HVAC systems at eleven separate community centers; (2) authorized a 10 percent change order authority in the amount up to \$79,900 for project changes including, but not limited to, unforeseen conditions or necessary design changes, for a total contract amount of \$878,900; and (3) authorized the City Manager, or designee, to execute a Construction Agreement with WCM & Associates, Inc., Yucaipa, including making minor and non-substantive changes.

#### AGREEMENT - WIRELINE FACILITIES - MARTIN LUTHER KING/GAGE CANAL

The City Council (1) approved the Agreement with University of California, Riverside for the attachment of wireline facilities on two City-owned wooden utility poles, at the rates set forth; and (2) authorized the City Manager, or his designee, to execute the Agreement for the attachment of wireline facilities to City-owned wood utility poles as set forth in said agreement.

#### WATER CONSERVATION SURCHARGE PROGRAM ENHANCEMENTS

The City Council approved (1) the increase to the annual Turf Removal Programs, Residential by \$175,000 for a total of \$400,000, and Commercial by \$400,000 for a total of \$700,000, for total increase of \$575,000; (2) rebate funding for High Efficiency Toilet Programs, Residential for \$10,000 and Commercial for \$40,000, for total of \$50,000; (3) rebate funding for a High Efficiency Clothes Washer Program in the amount of \$40,000; (4) the reduction for the Weather Based Irrigation Controller Program to \$15,000, a decrease of \$10,000; (5) the reduction for the High Efficiency Sprinkler Nozzles Program to \$5,000, a decrease of \$10,000; (6) the reduction to the Hose Bib Timer Program to \$2,500, a decrease of \$7,500; and (7) the reduction to the Residential Flow Monitoring Device Program to \$2,500, a decrease of \$22,500.

REQUEST FOR PROPOSAL 2344 - AGREEMENT - CITYWIDE LEADING PEDESTRIAN INTERVAL SIGNAL TIMING AND ENGINEERING DESIGN PLAN - MISSION INN/REDWOOD/SCOUT The City Council (1) approved a Professional Consultant Services Agreement in accordance with Request for Proposals No. 2344 with Advantec Consulting Engineers, Inc., Irvine, to complete the citywide leading pedestrian interval signal timing implementation and engineering design plan preparation services for the citywide retroreflective signal backplates and a median & high-friction surface treatment on Mission Inn Avenue between Redwood Drive and Scout Lane for a term of two years through June 30, 2026, with an option to extend for an additional two-year period, in the amount of \$884,712.31 plus a 10 percent contingency in the amount of \$88,471.23, for an amount not-to-exceed \$973,183.54; and (2) authorized the City Manager, or designee, to execute the Professional Services Agreement, including making minor and non-substantive changes and to extend the term, for up to two additional years, subject to the availability of budgeted funds.

AMERICAN RESCUE PLAN ACT EXPENDITURE PLAN UPDATE - PARKS MASTERS PLANS, SENIOR STUDY MASTER PLAN, AND REVOLVING LOAN - SUPPLEMENTAL APPROPRIATION - INTERFUND TRANSFER

Following discussion, it was moved by Councilmember Mill and seconded by Councilmember Robillard to (1) receive and file an update on the American Rescue Plan Act (ARPA) Expenditure Plan; (2) authorize the Chief Financial Officer, or designee, to record the reallocation of funds from various ARPA Projects of the American Rescue Plan Act Expenditure Plan to the Revenue Replacement projects in the amount of \$1,550,000 for Projects 2.13 PRCS-Parks Masters Plans (\$400,000), 2.14 Senior Study (\$150,000), and 2.17 Revolving Loan (\$1,000,000); (3) authorize the Chief Financial Officer, or designee, to record the reallocation of funds from various ARPA Projects of the American Rescue Plan Act Expenditure Plan to the Citywide Revenue Loss in the amount of \$391,359; (4) authorize the Chief Financial Officer, or designee, to allocate American Rescue Plan Act Expenditure Plan interest earnings in the amount of \$1,104,425 and record a supplemental appropriation and interfund transfer from the Grants and Restricted Programs Fund to the General Fund in the same amount to fund the previously approved Solid Waste SHARE Program; (5) authorize the Chief Financial Officer, or designee, to record an allocation of ARPA interest income in the amount of \$150,000 and to record a supplemental appropriation and interfund transfer from the Grants and

Restricted Programs Fund to the General Fund in the same amount to fund a consultant to complete a Parks Commission for Accreditation of Park and Recreation Agencies (CAPRA) Accreditation Strategy; (6) authorize the Chief Financial Officer, or designee, to record the reallocation of \$1,900,000 in previously allocated ARPA interest income from ARPA Expenditure Plan Revenue Replacement to the ARPA Program Interest Account and further exclude future interest income from the City's ARPA Expenditure Plan, consistent with ARPA guidelines; (7) reaffirm that the City Manager, or designee, has flexibility to reallocate funds from the proposed Expenditure Plan to other similar and eligible uses should feasibility or timeliness concerns arise, and to meet the statutory requirements of the ARPA Program; and (8) authorize the City Manager, or designee, to negotiate and execute any and all agreements, contracts and documents related to the approved reallocations in the Expenditure Plan for the American Rescue Plan Act funding, including making minor non-substantive changes. Public Hearing was called to consider Planning Case PR-2021-001145 (Title 20 Text Amendment) for proposed Code text amendments to Title 20 (Cultural Resources) of the Riverside Municipal Code including, but not limited to revision of owner consent requirement for historic designation, addition of noticing requirements for the demolition of historic structures, codification of Cultural Resource Report requirement for demolition,

addition of definitions for demolition and demolition by neglect, codification of the Certificate of Appropriateness application process; and revision of other non-substantive technical language and clarification, as needed. No one spoke on the matter. The public hearing was officially closed.

Following discussion, it was moved by Councilmember Mill and seconded by Councilmember Conder to (1) determine that Planning Case PR-2021-001145 is exempt from further California Environmental Quality Act (CEQA) review pursuant to Sections 15308 (Actions to Protect Environment), 15060(c)(2) (No Physical Change), 15060(c)(3) (Not A Project), and 15061(b)(3) (General Rule), as the proposed amendment will cause no direct or indirect change to the environment, does not meet the definition of a Project under CEQA, and it can be seen with certainty that the proposed amendment will not have an effect on the environment; (2) approve amendments 2, 3, 4, and 5 and remove amendment 1 from the recommendation in the staff report; (3) maintain the current ordinance stating no structure may be designated as a landmark or structure or resource of merit nor may any designation be modified or repealed without prior written consent of the owner; (4) introduce an Ordinance amending Title 20 (Cultural Resources) of the Riverside Municipal Code; and (5) refer amendment 1 to the Cultural Heritage Board to continue to work on the language. The motion carried with Councilmembers Falcone, Cervantes, Robillard, Conder, Mill, and Hemenway voting age and Councilmember Perry absent.

Whereupon, an Ordinance entitled, "An Ordinance of the City of Riverside, California, Amending Numerous Sections of Title 20 the Riverside Municipal Code Regarding Cultural Resources," was presented and introduced.
