2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
3 RIVERSIDE, CALIFORNIA, AUTHORIZING THE CITY OF RIVERSIDE  
4 TO RECEIVE THE DEPARTMENT OF CALIFORNIA HIGHWAY  
5 PATROL'S 2024/2025 CANNABIS TAX FUND GRANT PROGRAM  
6 AWARD IN THE AMOUNT OF \$148,364.83; AND AUTHORIZING THE  
7 EXECUTION OF NECESSARY GRANT DOCUMENTS BY THE CITY  
8 MANAGER, OR HIS DESIGNEE.

9 WHEREAS, the City of Riverside, by and through the Riverside Police Department  
10 ("RPD"), has applied for the Department of California Highway Patrol Cannabis Tax Fund Grant  
11 Program award in the amount of One Hundred Forty-Eight Thousand Three Hundred Sixty-Four  
12 Dollars and Eighty-Three Cents (\$148,364.83) for fiscal year 2024/2025 ("Grant Award") for the  
13 education, prevention, and enforcement of laws related to driving under the influence; and

14 WHEREAS, the City Council of the City of Riverside desires to approve the City of  
15 Riverside to receive the Grant Award and to authorize the City Manager and his designees to execute  
16 all necessary grant documents, including any grant agreements, to effectuate the acceptance of the  
17 Grant Award.

18 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,  
19 California, as follows:

20 Section 1: That the City of Riverside is approved to receive the Grant Award in the amount  
21 of One Hundred Forty-Eight Thousand Three Hundred Sixty-Four Dollars and Eighty-Three Cents  
22 (\$148,364.83) for fiscal year 2024/2025 from the Department of California Highway Patrol  
23 Cannabis Tax Fund Grant Program.

24 Section 2: That the City Manager, or his designee, is hereby authorized and directed to  
25 execute all necessary documents in connection with the Grant Award, including any contracts or any  
26 extensions or amendments thereof.
