THIS FIRST AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT ("First Amendment") is made and entered into this _____ day of _____, 2024, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation ("City"), and LEE & RO, INC., a California corporation ("Consultant"), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated March 22, 2021 ("Agreement"); and

WHEREAS, the Agreement is set to expire on December 31, 2024; and

WHEREAS, the City desires to have Consultant continue providing the services referenced in that Agreement; and

WHEREAS, the City and Consultant have agreed to extend the term of the Agreement by three (3) additional years through December 31, 2027; and

WHEREAS, the City and Consultant desire to add additional compensation in the amount of One Hundred Fifty-Six Thousand Forty-Two Dollars (\$156,042.00), for the extended term of the Agreement, for total compensation not to exceed Three Hundred Five Thousand Five Hundred Forty-One Dollars (\$305,541.00).

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

1. Section 2, Term, is hereby amended to extend the term of the Agreement by three (3) additional years, through December 31, 2027.

2. Section 3, Compensation/Payment, is hereby amended to add additional compensation in the amount of One Hundred Fifty-Six Thousand Forty-Two Dollars (\$156,042.00), for the extended term of the Agreement, for total compensation not to exceed Three Hundred Five Thousand Five-Hundred Forty-One Dollars (\$305,541.00).

3. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.


