

# PETITION FOR REMOVAL OF EXISTING PREFERENTIAL PARKING ZONES

## ADVANTAGES / DISADVANTAGES OF REMOVING PREFERENTIAL PARKING ZONES:

**Advantages:**

- Residents and their guests will not be required to display permits to legally park
- Arrangements for special events with multiple guests will not be required

**Disadvantages:**

- Long-term parking by non-residents / park patrons may filter into the residential area
- The amount of on-street parking available to residents and their guests may decrease
- Litter, noise and traffic created by non-residents may increase

We the undersigned request that the City of Riverside remove the existing "No Parking Any Time, except for residents with permits" Preferential Parking Zone (PPZ) on the south side of Eleventh Street from Redwood Street to Pine Street" and remove the exiting "No Parking Between the Hours of 9:00 p.m. to 5:00 a.m. except for residents with permits" Preferential Parking Zone (PPZ) on the north side of Eleventh Street from Pine Street to Redwood Street. By our signature we verify that we agree to the requests for removal of both existing Preferential Parking Zones which were previously implemented and are no longer needed. We understand that removal of the zones may result in overflow long-term parking from nearby parks, neighborhoods, school, or other outside sources onto our street. We further understand that on-street parking within this segment will no longer be restricted to vehicles with permits / residents and their guests only during the currently restricted days and times and will become open to all legally parked vehicles.
