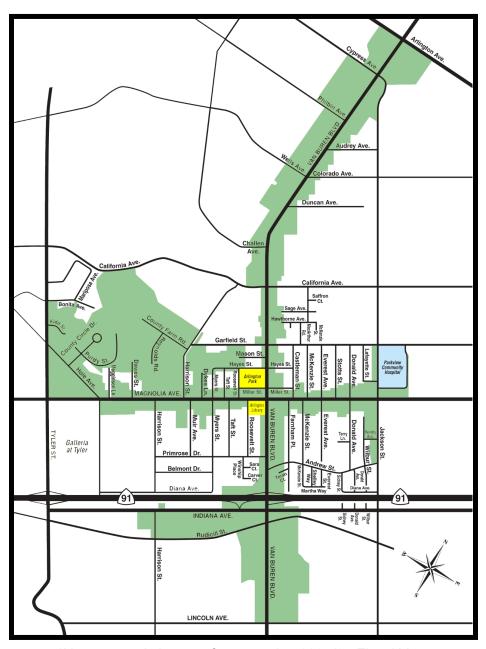

#### **Board Policies**

The Board of Directors approves the Annual Budget in October along with the upcoming Board of Directors & Executive Team along with approving RFP's on a Monthly Basis for projects with an estimated cost over \$10,000.00. Executive Team & Staff meet additionally monthly to focus on execution of Board decisions. Arlington Business Improvement District businesses get a 10% cost consideration on any RFP's along with preferential consideration to keep BID funds within Arlington.

#### **Arlington BID Benefits**

The ABP Vision is committed to the branding of Arlington as an attractive place to visit, work and do business; ABP operates the following programs focusing on the physical improvement and branding of the Arlington Business Improvement District.

#### Marketing

#### Beautification

Physical Improvement Program Grants - Matching Funds are provided up to \$1,000 for eligible improvements included but not limited to: exterior painting, new signage, exterior security cameras, parking lot resurfacing and lighting.

Vandalism Repair Grants - Matching Funds are provided up to \$1,000 for eligible repairs such as: window replacement.

Volunteer Group: Arlington Community Action Group - Trash Cleanup Projects 1-2 a month, Graffiti 311 Reporting, Pressure Washing for Bus Shelters, Mural Project scheduled for Oct 12th, Adopt-An-Alley partnership w/ KRCB

#### **Arlington BID - Tax Assessment**

The method and basis for levying the assessment in sufficient detail to allow each business owner to estimate the amount of the assessment to be levied against his or her business for the year.

#### **BID Tax Assessment Calculation**

90% of a business owner's current business tax, with a \$400 maximum cap be applied within the existing boundaries of the Arlington BID.

The method for levying this 90% tax assessment is to take the base business tax levied by the City of Riverside and increase it by 90%.

EXAMPLE BUSINESS TAX PAYMENT - 90% ASSESSMENT WITH \$400 MAXIMUM CAP

Base Business Tax + Arlington BID Assessment Fee(Base multiplied by 0.90) = Total Business
Tax Due

Example #1 \$100.00 + \$90.00 = \$190Example #2 \$1,000.00 + \$900.00 (\$400) = \$1,900 (\$1,400)

#### **No Proposed Changes**

At this time the Arlington Business Partnership is not proposing any BID Tax Assessment changes for the upcoming 2024/25 Fiscal Year.
