ISSUE:

That the Community Police Review Commission receive and file a communications report for the months of October 2024 - January 2025.

DISCUSSION:

The following Police Department related items were agendized for the City Council as noted below:

October 22, 2024

- (1) Isaac Hiraes resigns from the Community Police Review Commission, and Lori A. Pendergraft is appointed to the Commission on Aging Citywide seat.

November 5, 2024

- (1) Joshua A. Kopp is appointed to the Park and Recreation Commission Ward 5 seat, while Leah Stuart is appointed to the Commission on Disabilities Ward 2 seat. Resignations from Mohammad Noor from Park and Recreation Commission and David Prince from Community Police Review Commission.
- (2) The City of Corona has signed an Amended Aviation Program Agreement for \$120,000 to provide emergency air support services until June 30, 2025.

November 19, 2024

- (1) Approval of the acceptance of the following grants: \$490,000 from the State of California Office of Traffic Safety for the Selective Traffic Enforcement Program, \$25,000 for the Child Passenger Safety Program, and \$20,000 for the Motorcycle Safety Program. These funds will support overtime operations for bicycle and pedestrian enforcement, distracted driving operations, general traffic enforcement, motorcycle safety training, child safety seat education, distribution of child safety seats to families in need, and DUI saturation patrols and checkpoints, covering the period from October 1, 2024, through September 30, 2025.

December 10, 2024

- (1) Steven R. Bell was appointed to the Community Police Review Commission for Ward 3 seat.
- (2) Accepted 2025 California Citizens' Option for Public Safety Program grant of \$489,055 (or actual amount) and growth payment into the Special Deposits Fund, Police State COPS Funding Program Account.
- (3) Agreement with the City of San Diego Police Department Internet Crimes against Children Task Force and appropriate \$120,000 to reimburse City approved expenditures.

December 17, 2024

- (1) Approved letter of consent with Epic Aviations, LLC. To re-assign Purchase Order 250024 to Ascent Aviation Group, Inc. for purchase and delivery of Jet-A Aviation Fuel for City helicopters for \$122,475 from October 1, 2024 through June 30, 2025. Approved two one-year renewal periods with Ascent Aviation Group, Inc., for purchase and delivery of Jet-A Aviation Fuel products in the amount of \$260,150 for Fiscal Year 2025-26. And \$286,165 for Fiscal year 2026-27 including 10 percent annual increase from General Fund.

January 7, 2025

- (1) Declare Police Service Dog "Ricc-Vigo" as retired and surplus. Donate Police Service Dog to his current handler Officer Joseph Cleary, at no cost to City.
