AMERICAN RESCUE PLAN ACT EXPENDITURE PLAN UPDATE AND REALLOCATION OF FUNDS Following discussion, it was moved by Councilwoman Plascencia and seconded by Councilmember Hemenway to (1) receive an update on the American Rescue Plan Act Expenditure Plan; (2) authorize the Chief Financial Officer, or designee, to record the reallocation of funds from various American Rescue Plan Act Expenditure Plan Projects to the Citywide Park Improvement Program in the amount of \$3,000,000; (3) authorize the Chief Financial Officer, or designee, to record the reallocation of funds from various American Rescue Plan Act Expenditure Plan Projects to General Fund Revenue Replacement in the amount of \$1,019,477; (4) reaffirm City Manager, or designee, flexibility to reallocate funds from the proposed Expenditure Plan to other similar and eligible uses should feasibility or timeliness concerns arise; (5) authorize the City Manager, or designee, to negotiate and execute all agreements, contracts and documents related to the approved reallocations in the Expenditure Plan for the American Rescue Plan Act funding, including making minor non-substantive changes; and (6) refer the reallocation of funds from Category 2 Negative Economic Impacts of \$123,767 from Nonprofit Grant Support, \$500,000 from Nonprofit Partner Community Programs and \$550,000 from Essential Agriculture Workforce Development to the Economic Development, Placemaking, and Branding/Marketing Committee for consideration.
