

**FIRST AMENDMENT TO  
MEMORANDUM OF UNDERSTANDING  
FOR REIMBURSEMENT OF CROSSING GUARD SERVICES**

**ALVORD UNIFIED SCHOOL DISTRICT**

THIS FIRST AMENDMENT TO MEMORANDUM OF UNDERSTANDING FOR REIMBURSEMENT OF CROSSING GUARD SERVICES ("First Amendment") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 202\_, by and between the CITY OF RIVERSIDE ("City"), a California charter city and municipal corporation, and the ALVORD UNIFIED SCHOOL DISTRICT ("District"), a California public school district, herein "the Parties", with respect to the following:

**RECITALS**

WHEREAS, on or about September 25, 2019, City and District entered into that certain Memorandum of Understanding for Reimbursement of Crossing Guard Services; and

WHEREAS, the City and District desire to add twelve (12) additional crossing guard locations, with the District to reimburse One Hundred Percent (100%) of the costs for the additional locations to the City.

NOW, THEREFORE, in consideration of the foregoing recitals which are incorporated herein by this reference, City and District agree as follows:

1. Exhibit "A" is hereby amended to add twelve (12) additional crossing guard locations set out in Exhibit "A-1", attached hereto and incorporated herein by this reference.
2. Section 3, Compensation, is amended to provide that for the twelve (12) additional crossing guard locations, the District shall reimburse the City for One Hundred Percent (100%) of the actual costs of the crossing guards, estimated to be One Hundred Forty-Six Thousand Five Hundred Dollars (\$146,500.00), in accordance with the provisions of the Cost Sharing Schedule attached hereto as Exhibit "B-1" and incorporated herein by this reference.
3. All other terms and conditions of the Memorandum of Understanding for Reimbursement of Crossing Guard Services between the parties which are not inconsistent with the terms of this First Amendment shall remain in full force and effect as if fully set forth herein.
