BACKGROUND

- Electric System Plannings Five-Year Plan recommends upgrades to Harvey Lynn Substation Transformer T3 getaways
- 2. The project will upgrade getaways for circuits 1287, 1289, and 1291
- 3. Circuits 1287 and 1289 are on the Worst Performing Circuit list, exceeding 100% loading

DISCUSSION

- This project will modernize our electric distribution infrastructure by replacing aging 750 kcmil aluminum XLPE cable with a higher capacity 1100 kcmil EPR cable and related electric distribution facilities
- 2. The upgrade will enhance system reliability, increase load carrying capability, and support future growth demands

- The project is located on La Sierra Avenue, south of Pierce Street, north of Collet Avenue, on Schuyler Avenue and Minnier Avenue, and inside Harvey Lynn Substation
- Customer notifications will be sent out prior to any service disruptions
- 3. Electric Service Disruptions will be coordinated to minimize impact to customers

SCOPE OF WORK

- 1. Installation/replacement of approximately 4,500 circuit feet of primary feeder cables
- 2. 6 weeks to complete scope of work
- 3. Work performed by RPU Field crews
