BACKGROUND

- City Charter section 412 authorizes the City Council to establish, and uniformly apply rules for the conduct of proceedings
- 2. City Council meeting procedures are set out in Resolution 24255
- 3. City Council is to review and revise as needed or every two years. (Art. XVI., Sec. A Administration)

BACKGROUND

- 1. On June 5, 2025, and August 6, 2025, the Governmental Processes Committee (GPC) reviewed potential changes to the City Council Rules and Procedures and Order of Business Resolution
- 2. GPC made several recommendations for changes and directed the item be forwarded to the City Council for review

MEETING SCHEDULES

GPC Recommendation

Meeting Schedules

- 1. Amend summer schedule to remove September and July and August meetings to be on second and fourth Tuesdays.
- 2. Remove sentence in section VIII.D regarding meetings in April, June, and October.

Resolution Revision

Revisions in Art. VIII.D:

- 1. For the months of July, and August and September, meetings shall occur on the second first and fourth third Tuesdays of the month.
- 2. For the months of April, June, and October, meetings shall occur the second, third, and fourth Tuesdays of the month.

11. Allotted time for members to debate an item with the presiding officer to keep time.

Revisions in XII.E

11. Allotted Time for Debate. waived by a majority of the City Council, each member may speak on an item for up to fifteen (15) minutes as provided in this paragraph. first time a member is recognized to speak on an item, the member shall limit his/her remarks to ten (10) minutes. Subsequent opportunities to speak shall be no more than five (5) minutes. The presiding officer shall be responsible for tracking time and shall utilize the timing system for this purpose.

12. Additional research was determined necessary regarding appointments to Regional Organizations. The **GPC** requested research from City departments to determine the potential number of regional boards in which the City participates.

12. Eligibility for appointment to a regional organization board is based on the law or agreement governing each organization. Appointments are made in accordance with each organization's applicable law. Based on this research the following revision was made to Article XIII, Section A: organizations are external organizations where the City Council directly appoints a person to represent the City's interests in that organization. The provisions of this section shall not apply to organizations where the City Council is not the appointing authority. When possible, appointments to regional organizations should be limited to elected officials."
