
ORAL COMMUNICATIONS FROM THE AUDIENCE

EXCUSED ABSENT REPORT



DISCUSSION CALENDAR

SEPTEMBER 2025 AIRPORT MANAGERS' REPORT

Airport Manager Daniel Prather began his report by updating the Commission on airport operations and financial statistics. Prather showed that the airport is under in expenditures due to making repairs in house and over in revenues.

Prather updated the Commission on a few highlights over the past several months including the airport's most recent inspection received from CALTRANS Aeronautics. The

inspection report included several cracking issues located in several runways and taxiways around the airport as well as a tree that needed to be trimmed. Prather discussed the San Bernadino Valley College/ Riverside Flight Academy partnership kickoff event as well as the new observation area located beneath the tower. Prather alluded to the new concrete pad for additional seating in front of the terminal and new airfield signage located at taxiway Lima.

Prather concluded his report by informing the Commission of the upcoming City Council items which include the Airport Master Plan Project to Coffman and Associates as well as the terminal painting project and the airport roofing project. Prather stated that the new marquee project is scheduled for the October City Council Meeeting.

Commissioner Trigueros stated that the observation area was a good call and asked if the airport considered a playground or aviation themed play area giving examples of other airports.

Prather stated that he has reached out to several playground manufacturers and does have examples but also stated that costs exceed expectations.

Gibbs asked if any funding was available through the City Parks and Recreation Department.

Prather stated that he would investigate that option.

Delpino asked what the goal of the new airport master plan is

Prather said the goal was to find additional funding available as well as facilities needed for future demand, land development, parking and projections of future operations. Prather also informed the commission that a Planning Advisory Committee is planned to help with the direction of the plan.

A motion was made by Commissioner Gamblin and seconded by Commissioner Alderette to approve the September Airport Mangers Report. The Commission unanimously approved item number 5.
