##### AMENDMENT AGREEMENT – EXISTING REVOLVOING CREDIT – PUBLIC UTILITIES – WATER FUND AND ELECTRIC FUND DEBT - RESOLUTION

Public Hearing was called to amend and extend existing revolving credit agreement with Water Utility for \$25 million and Electric Utility for \$35 million, for additional three years and three months for estimated cost of \$413,500 from Public Utilities - Water Fund and Electric Fund Debt Related Fiscal Charges Account. Two people spoke on the matter. The public hearing was officially closed.

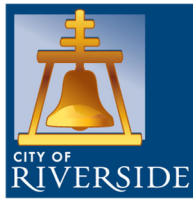

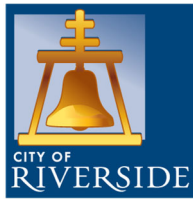

#### RULES OF PROCEDURE AND ORDER OF BUSINESS - RESOLUTION

The City Council adopted a resolution to revise the City Council Rules of Procedure and Order of Business to clarify the use of technology by members of the public; whereupon, the title having been read and further reading waived, Resolution No. 24255 of the City Council of the City of Riverside, California, Establishing Rules of Procedure and Order of Business for the City Council of the City of Riverside and Related Functions and Activities and Rescinding All Prior Actions Taken Thereto, and Repealing Resolution No. 24076, was presented and adopted.

#### CASE PR-2024-001758 - SUMMARY STREET/ALLEY VACATION - RESOLUTION

The City Council (1) determined that Case PR-2024-001758 is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3) (Common Sense) of the CEQA Guidelines, as it can be seen with certainty that there is no possibility the project will have a significant effect on the environment; (2) approved Planning Case PR-2024-001758 (VC-S) for the Summary Street/Alley Vacation of 6,578 square feet of an existing unimproved alley, subject to the recommended conditions of approval; (3) adopted resolution vacating the existing unimproved alley pursuant to the Public Streets, Highways and Service Easements Vacation Law (Attachment 1); and (4) authorized the City Manager, or his designee, to execute quitclaim deeds associated with the summary

### RIVERSIDE MUNICIPAL CODE AMENDMENT - CANNABIS BUSINESS ACTIVITIES - ORDINANCE INTRODUCED

The City Council (1) introduced an Ordinance, amending Chapter 5.77 of the Riverside Municipal Code regarding Cannabis Business Activities; (2) adopted a Resolution amending the Storefront Retail Commercial Cannabis Business Permit Procedure Guidelines; whereupon, the title having been read and further reading waived, Resolution No. 24257 of the City Council of the City of Riverside, California, amending Resolution No. 24048 by modifying the Storefront Retail Commercial Cannabis Business Permit Procedure Guidelines and Application Review Criteria for the City of Riverside's Cannabis Program, was presented and adopted. Councilmember Perry voted no and Councilmember Hemenway abstaining.

### RIVERSIDE MUNICIPAL CODE AMENDMENT - ORDINANCE ADOPTED

The City Council adopted an ordinance amending the Riverside Municipal Code (RMC) Chapter 3.30 Section 3.30.030 - Schedule of Regulation, Product and Services; Whereupon the title having been read and further reading waived, Ordinance No. 7713 of the City of Riverside, California, Amending Chapter 3.30 of the Riverside Municipal Code, to add five additional categories and remove one category to the Schedule of Regulation, Products, and Services, was presented and adopted.

### RIVERSIDE MUNICIPAL CODE PROPOSED AMENDMENT - AMBULANCE SERVICES

The City Council (1) approved the proposed amendments to the Riverside Municipal Code - Chapter 5.66 – Ambulances; and (2) directed the City Attorney Office to prepare a resolution to adopt recommended changes to RC 5.66.

#### AGREEMENT AMENDMENT – SUBSCRIPTIONS FOR DIGITAL ACCESS

The City Council (2) authorized the purchase of 18 Motorola Enhanced APX 6500 7/800 MHZ Mobile in-car radios, radio accessories, and three-year service warranty from Motorola Solutions Inc., Chicago, Illinois, in the amount of \$141,184.88; (2) authorized the purchase of 18 WatchGuard in-car video systems from Motorola Solutions, Inc., Chicago, Illinois, including miscellaneous accessories, software, licensing, and warranty in the amount of \$154,478.07; (3) authorized the purchase of 15 Panasonic CF-33 Toughbooks, five-year warranty, and accessories from LEHR, Reno, Nevada, in the amount of \$113,848.46; and (4) authorized the City Manager, or designee, to execute all documents necessary to issue the purchase orders and change orders, including making minor and non-substantive changes.

Following discussion, it was moved by Councilmember Falcone and seconded by Councilmember Conder to (1) award a construction contract for Bid No. 8046 for the construction of Fiscal Year 2023/2024 Arterial and Minor Streets Maintenance, Phase 3 to Onyx Paving Company, Inc., Anaheim, California, in the amount of \$6,593,000; (2) authorize the City Manager, or designee, to execute the Construction Contract with Onyx Paving Company, Inc., including making minor and non-substantive changes, subject to the availability of budgeted funds; and (3) with at least five affirmative votes, authorize the Chief Financial Officer, or designee, to record a supplemental appropriation and interfund transfer from the General Fund Infrastructure Reserve into the Capital Outlay Fund, Monticello Landscape Maintenance project account in the amount of \$280,000. Following discussion, it was moved by Councilmember Falcone and seconded by Councilmember Cervantes to (1) approve the revised Historic District Sign Program as presented in the staff report; (2) authorize the Chief Financial Officer, or designee, to record a supplemental appropriation in the amount of \$135,292 in the Grants & Restricted Programs Fund, Historical District Sign Program expenditure account, offset by funds to be transferred from the Interest-Bearing Special Deposits Fund, Historical Preservation Trust, for the purposes of the Historic District and Spanish Town Road sign programs, Landmark Plaques program, and to complete a historic district survey; (3) approved the preparation of Title 20 Code text amendment and ordinance to remove Section 20.30.030 (Historic Preservation Fund) from the Riverside Municipal Code by staff. The motion carried unanimously.

#### FOURTH AMENDMENT TO AGREEMENT - CROSSING GUARD PROGRAM MANAGEMENT SERVICES

Following discussion, it was moved by Councilmember Mill and seconded by Councilmember Cervantes to (1) approve the Fourth Amendment to Professional Consultant Services Agreement with All-City Management Services (ACMS), Inc. Santa Fe Springs, California, for Crossing Guard Program Management Services to add three (3) guard locations for a total of 87 guard locations through June 30, 2026, for an amount not to exceed \$66,192, for a total contract value of \$1,919,568 for fiscal year (FY) 2025/26;
