- 9. Director's Update regarding the main museum renovation, historic houses, collections, exhibitions and programs, staffing, advisory teams, volunteer and support opportunities, marketing, and communications.

In addition to the published report Director Peterson reported that the Museum's 100 activities to celebrate its 100th Anniversary have begun. A new program on the 3rd Friday at Heritage House is titled "Movies on the Lawn: Made in Riverside," which features films that have segments filmed in Riverside. Pfeiffer Partners' lead architect for the main Museum Stephanie Kingsnorth gave a presentation on the Museum renovation project to Leadership Riverside. The Riverside Public Utilities Board approved the lease for the Museum to rent office space in Mission Square for 7/8 staff during the renovation; it will now go to City Council for approval. New Manager of Curatorial Services Jennifer Dickerson will begin February 16th. That brings the Museum's FTEs to 13.5, which is all of the department's funded positions.
