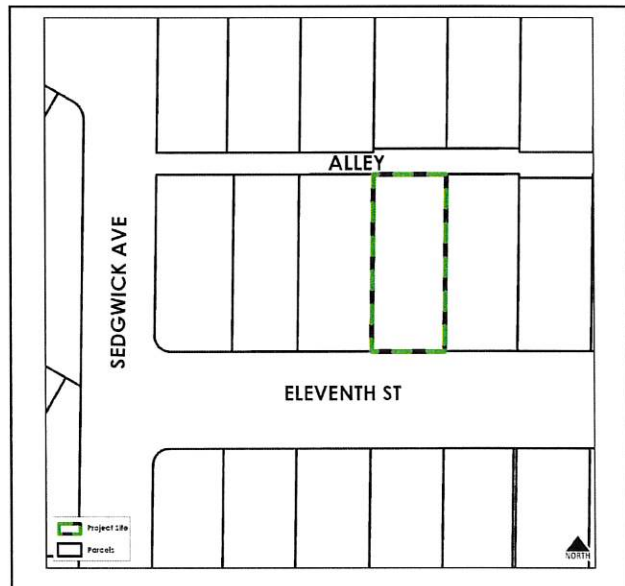

# CITY OF RIVERSIDE NOTICE OF PUBLIC HEARING HISTORIC DESIGNATION – OKUBO RESIDENCE

**YOU ARE HEREBY NOTIFIED** that the City Council of the City of Riverside will hold a Public Hearing regarding the following item:

**CASE NUMBER:** DP-2024-00577 (Historic Designation)  
**APPLICANT:** Valerie Silva  
**LOCATION:** 5310 Candlewick Court, 2356 Eleventh Street, on the north side of Eleventh Street between Sedgwick and Eucalyptus Avenues, in Ward 1.



**PROPOSAL:** The Cultural Heritage Board recommends that the City Council consider approval of a Historic Designation request to designate the Okubo Residence as a City Landmark.

**ENVIRONMENTAL DETERMINATION:** The Cultural Heritage Board recommends that the City Council determine that this proposal is exempt from the California Environmental Quality Act (CEQA), pursuant to Sections 15061(b)(3) (Common Sense Rule) and 15308 (Actions by Regulatory Agencies for Protection of the Environment), as this proposal will not have a significant effect on the environment, preserve the historic character of a cultural resource, and provide notice of the resource historic status.
