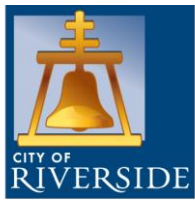
MINUTES

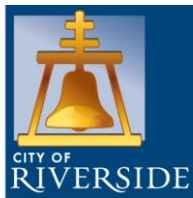
COMMUNICATIONS
