

1 RESOLUTION NO. 24246

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, ADOPTING THE CITY OF RIVERSIDE LOCAL HAZARD
4 MITIGATION PLAN 2023 ANNEX FROM THE RIVERSIDE COUNTY
5 OPERATIONAL AREA MULTI-JURISDICTIONAL LOCAL HAZARD
6 MITIGATION PLAN AS REQUIRED BY THE FEDERAL DISASTER
7 MITIGATION AND COST REDUCTION ACT OF 2000.

8 WHEREAS, President William J. Clinton signed H.R. 707, the Disaster Mitigation and Cost
9 Reduction Act of 2000, into law on October 30, 2000; and

10 WHEREAS, the Disaster Mitigation Act of 2000 requires all jurisdictions to be covered by a
11 Local Hazard Mitigation Plan to be eligible for Federal Emergency Management Agency post-disaster
12 funds; and

13 WHEREAS, The City of Riverside has committed to participate in the development of the
14 Riverside County Operational Area Multi-Jurisdictional Local Hazard Mitigation Plan; and

15 WHEREAS, the Riverside Fire Department – Office of Emergency Management coordinated
16 the development of the City of Riverside Local Hazard Mitigation Plan Annex; and

17 WHEREAS, the City of Riverside is concerned about mitigating potential losses from natural
18 disasters before they occur; and

19 WHEREAS, the plan identifies potential hazards, potential losses, and potential mitigation
20 measures to limit losses; and

21 WHEREAS, the California Governor's Office of Emergency Services has reviewed the plan
22 on behalf of the Federal Emergency Management Agency; and

23 WHEREAS, formal adoption of the plan by the City of Riverside is required before final
24 approval of the plan can be obtained from the Federal Emergency Management Agency; and

25 WHEREAS, The Riverside Fire Department – Office of Emergency Management has
26 determined that it would be in the best interest of the City of Riverside to adopt the City of Riverside
27 Local Hazard Mitigation Plan 2023 Annex from the Riverside County Operational Area Multi-
28 Jurisdictional Local Hazard Mitigation Plan.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
California, as follows:
