Our records indicate you reside in an existing Preferential Parking Zone (PPZ). The current PPZ permit program is expiring on June 30, 2024. As part of our commitment to providing more accessible parking throughout your community, we would like to inform you that we are now accepting PPZ applications for the upcoming three-year PPZ permit program starting July 1, 2024, through June 30, 2027.

Here are some key details about the PPZ renewal process and important guidelines regarding the use of your PPZ permit:

**Renewal Deadline:**

To maintain PPZ permit continuity, it is important to complete the PPZ renewal application and submit it before May 31, 2024. The next PPZ program will begin July 1, 2024, and will end on June 30, 2027.

**Current PPZ Fee:**

The current PPZ fee is \$42 through June 30, 2024. Please note that this fee is subject to change on July 1, 2024, based on an annual fee study and City Council's approval. We will provide notifications should any fee changes occur.

**Renewal Options:**

**ONLINE:**

Create an account (or use existing account) to apply and pay for your application at [Riverside.PermitInfo.net](http://Riverside.PermitInfo.net).

**MAIL:**

Complete the PPZ application available on the website and include a check payable to the City of Riverside. Do not send cash. Please mail application and payment to: City of Riverside Permit Processing PO Box 10479 Newport Beach, CA 92658-0479. Please be sure to include a phone number and email address in case there are questions on your application.

**IN-PERSON:**

Visit the Parking Services Division at 3900 Main Street, 4th Floor, Riverside CA 92522 to submit the PPZ application and payment.

**Permit Usage Guidelines:**

Resident Permits are issued to a specific vehicle and are non-transferable between vehicles. They are issued to residents who have provided proof of residency, including a current State of California vehicle registration showing residency within a Preferential Parking Zone (PPZ) within the City of Riverside.

Guest permits shall be used solely for visiting the resident to which the PPZ permit is registered and only for the duration of the visit. Upon the arrival of a new guest, PPZ Residents must enter their guests license plate into the online portal at: [Riverside.PermitInfo.net](http://Riverside.PermitInfo.net). This must be done for every guest, every visit.

Virtual PPZ permits will replace the decal PPZ permits. License plates will be scanned to verify valid PPZ permits. Optional paper PPZ permits will be made available online for those that want to display their PPZ permit on the dashboard; however, this is not required. PPZ permits will not be mailed out, and only accessible online.

Use of a PPZ permit signifies the parked vehicle is not subject to the posted Preferential Parking Zone (PPZ) restriction. All other regulations continue to apply (e.g., the Municipal Code prohibits storage of vehicles on the street for more than 72 consecutive hours or parking during street sweeping hours).

The permit does not provide a reservation of any parking space.
