

NOTICE OF PUBLIC HEARING REVENUE BONDS SUNRISE AT BOGART

NOTICE IS HEREBY GIVEN that on November 19, 2024, a public hearing as required by Section 147(f) of the Internal Revenue Code of 1986 will be held with respect to a proposed plan of finance that includes the issuance and reissuance from time to time, by the California Municipal Finance Authority (the "Authority"), of one or more series of revenue bonds in an outstanding principal amount not to exceed \$15,000,000 (the "Bonds"), to finance and refinance the acquisition, [construction, development and equipping] of a 23-unit qualified residential rental project located at 11049 Bogart Avenue (the "Project") in the City of Riverside, California (the "City"). The Project is to be owned and operated by Sunrise at Bogart, LP, a California limited partnership, or by another ownership entity to be created by its general partner, Sunrise at Bogart LLC, a California limited liability company, or by another affiliate of such general partner's sole member, Many Mansions, a California nonprofit public benefit corporation (such limited partnership or other ownership entity, the "Borrower").

The Bonds and the obligation to pay principal thereof and interest thereon and any redemption premium with respect thereto do not constitute indebtedness or an obligation of the City, the Authority, the State of California or any political subdivision thereof, within the meaning of any constitutional or statutory debt limitation, or a charge against the general credit or taxing powers of any of them. The Bonds shall be limited obligations of the Authority, payable solely from certain revenues duly pledged therefor and generally representing amounts paid by the Borrower.
