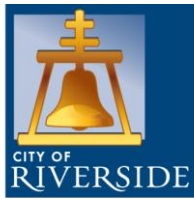

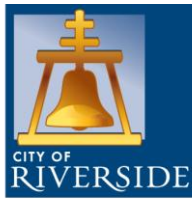

Three people spoke on the matter.

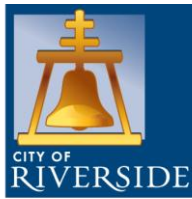

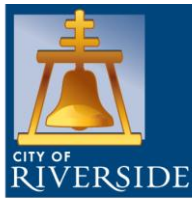
RIVERSIDE MUNICIPAL CODE AMENDMENT - CHAPTER 9.56 - ORDINANCE INTRODUCED

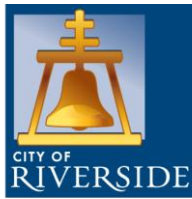
TRANSIT PROEJECTS GRANTS - THIRD STREET GRADE SEPARATION - SUPPLEMENTAL APPROPRIATIONS - RESOLUTION

The City Council (1) authorized acceptance of \$15 million in Federal Railroad Administration Rail Crossing Elimination Program grant funds, \$22 million in state Transit and Intercity Rail Capital Program (TIRCP) grant funds, and \$3 million in federal Community Project Funding/Congressionally Directed Spending (CPFCDs) CA999 Earmark funds; (2) authorized the City Manager, or designee, to digitally execute all necessary grant documents via the GrantSolutions.gov portal; (3) adopted a Resolution agreeing to comply with all conditions, statutes, regulations and guidelines for state-funded transit projects, and authorize the City Manager, or designee, to execute the Master Agreement, all award agreements, Program Supplements, and any amendments thereto with the California Department of Transportation; and (4) authorized the Chief Financial Officer, or designee, to record an increase in revenues in the amount of \$40 million and appropriate expenditures in the same amount in the Capital Outlay-Grants Fund, for various capital projects as outlined in the fiscal impact section of the report.

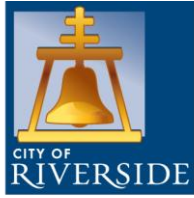

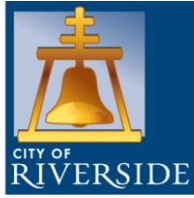
