SUBJECT: RIVERSIDE POLICE DEPARTMENT PARTICIPATION IN VARIOUS LOCAL, STATE AND FEDERAL TASK FORCES IN THE REIMBURSEMENT AMOUNT OF \$461,872.30 - SUPPLEMENTAL APPROPRIATION(S)

ISSUE:

Authorize supplemental appropriations for the participation of the Riverside Police Department in various local, state, and federal task forces in the amount of \$461,872.30.

RECOMMENDATIONS:

That the City Council:

1. With at least five affirmative votes, authorize the Chief Financial Officer, or designee, to record an increase in revenue and authorize supplemental appropriations in the amount of \$461,872.30 in the Grants and Restricted Programs Fund, Various Programs (listed in the Background below); and
2. Authorize the City Manager, or designee, to execute all documents necessary to receive reimbursement of funds for services performed in cooperation with the task forces listed, herein.

BACKGROUND:

The Riverside Police Department (RPD) participates in several regional task forces that receive various local, state, and federal funding reimbursements to help offset costs. Task force purpose and projected reimbursements are as follows:

Riverside Auto-Theft Interdiction Detail (RAID) Task Force

Formed in 1993, the multi-jurisdictional task force concentrates its efforts on the detection, identification, and apprehension of the professional vehicle thieves operating in Riverside. The City Council approved the City's participation in RAID through a Memorandum of Understanding (MOU), on April 12, 1994. Participation in the RAID task force will fund 70 percent of one full-time police officer position and 150 hours of overtime in the estimated amount of \$140,212.30, as well as equipment, training and other necessary operating expenses by the Riverside County Sheriff's Office.

High Intensity Drug Trafficking Area (HIDTA)

The City of Riverside falls within the Southwest Border High Intensity Drug Trafficking Area (HIDTA) region. The HIDTA program enhances drug control efforts by providing additional resources to combat drug trafficking and its harmful consequences. RPD has one detective assigned to this task force. Task force related overtime per the Memorandum of Understanding between the United States Drug Enforcement Administration (DEA) and Riverside Police Department is reimbursed up to \$17,774.75 by the United States Drug Enforcement Administration.

California's Department of Justice Inland Narcotic Crackdown Allied (INCA) Task Force

Focuses on cocaine and money laundering activities in the Inland Empire region with heroin and marijuana interdiction as a secondary mission. RPD has one detective is assigned to the INCA task force. The overtime is reimbursed by the State of California Department of Justice for up to \$19,840.75 per detective.

As part of the INCA task force, the RPD is also reimbursed by the State of California Department of Justice for helicopter maintenance up to \$20,000 for the use of a helicopter on task force operations.

Inland Violent Crime Suppression (IVCS) Task Force

Mission is to identify and target for prosecution criminal enterprise groups and individuals responsible for crimes of violence, as well as to focus on the apprehension of dangerous fugitives where there is or may be a federal investigative interest. RPD has three detectives assigned to this task force. Task force related overtime is reimbursed up to \$19,840.75 by the Federal Bureau of Investigation per detective.

Alcohol Tobacco and Firearms (ATF) Task Force

Investigates violations of federal firearms, arson, explosives, and narcotics laws aimed at reducing violent crimes in the City of Riverside and surrounding areas. RPD has one detective assigned to this task force. Overtime for this task force is reimbursed up to \$19,840.75 by the United States Department of Justice, Bureau of Alcohol, Tobacco and Firearms per detective.

Orange County Regional Computer Forensics Laboratory (OCRCFL)

Provides services for forensic examinations, collaboration, and training in order to provide high quality, uniform computer forensic support in the region. RPD has one detective assigned to this task force. Overtime for this program is reimbursed up to \$19,840.75 by the Federal Bureau of Investigations per detective.

Internet Crimes against Children (ICAC) Task Force

San Diego Police Department is the recipient of federal and state grant funds from the United States Department of Justice, Office of Juvenile Justice and Delinquency Prevention and the California Governor's Office of Emergency Management. The San Diego Police Department uses these funds to administer and operate ICAC Task Force. The purpose of the task force is to investigate and prosecute those who sexually exploit children through the use of the Internet and/or computers; provide training and equipment to those involved in investigating and prosecuting ICAC; and provide community education regarding the prevention of ICAC related crimes. The Riverside Police Department will receive reimbursement for salary costs of one detective position in an amount up to \$100,000 and overtime costs up to \$15,000.

Inland Regional Child Exploitation and Human Trafficking (IRCEHT) Task Force

Focuses to identify and rescue victims of child exploitation and human trafficking; to reduce the vulnerability of children and adults to sexual exploitation and abuse. RPD has one detective assigned to this task force. Task force related overtime will be reimbursed up to \$19,840.75 by the Federal Bureau of Investigation per detective.

Homeland Security Investigations (HSI) Task Force

Focuses to enhance the State's ability to prepare for, prevent, and respond to terrorist attacks and other major disasters. RPD has one detective is assigned to the HSI task force. Task force related overtime will be reimbursed up to \$30,000 by the Federal Bureau of Investigation.

DISCUSSION:

Participation on task forces helps the Riverside Police Department ensure a well-coordinated law enforcement effort and increases the flow of intelligence information among the various law enforcement agencies in the region.

STRATEGIC PLAN ALIGNMENT:

This item contributes to Strategic Priority No. 2 Community Well-Being and Goal number No. 2.4 – Support programs and innovations that enhance community safety, encourage neighborhood engagement, and build public trust.

This item aligns with EACH of the five Cross-Cutting Threads as follows:

- 1. Community Trust** – The Riverside Police Department is dedicated to improving quality of life by creating a safe environment in partnership with the people it serves. RPD's ability to partner with Federal, county and local agencies serves to benefit the public safety of the City's diverse populations, and results in the greater public good.
- 2. Equity** – RPD provides public safety services to all residents in the City of Riverside. The partnership between RPD and other law enforcement agencies help provide equitable distribution of public safety services.
- 3. Fiscal Responsibility** – RPD's participation in the previously mentioned task forces provide reimbursement for partnership opportunity and reduces the burden on the General Fund.
- 4. Innovation** – RPD must constantly change and adapt to meet the community's changing needs and prepare for the future. These partnerships provide the Department with additional resources and funding to achieve this goal.
- 5. Sustainability & Resiliency** – Reimbursements from these programs allow RPD to meet the needs of the present without compromising the needs of the future and ensures the City's capacity to preserves, adapt and grow.

FISCAL IMPACT:

The total impact of this action is \$461,872.30. Upon Council approval, the increases in revenue and appropriated expenditures will be recorded in the Grants and Restricted Programs Fund in the Programs/Accounts listed in the table below:

Some of the funds will be received in the Federal fiscal year, which spans October 1, 2022 through September 30, 2023, some of the funds will be received in the calendar year, which spans January 1, 2023 through December 31, 2023, and some of the funds will be received in the local fiscal year, which spans July 1, 2022 through June 30, 2023, it is anticipated that approximately \$352,707.30 will be received in FY 2022/23 and the remaining funding in the approximate amount of \$109,165.00 will be received in FY 2023/24.

The timing of the reimbursements may vary dependent upon overtime worked by assigned officers and needed helicopter maintenance. Once the maximum reimbursement is reached, there will be no further reimbursements.
