BACKGROUND

- 1. October 18, 2013 Board approved Work Order No. 0809099 and Work Order No. 0809101 for the Wood Streets Streetlight Replacement Project, Phase 1
- **2. February 13, 2017** Board approved Work Order No. 1523553 for the Wood Streets Streetlight Replacement Project, Phase 2
- 3. November 21, 2018 Cultural Heritage Board recommended City Council approve the Certificate of Appropriateness for the Streetlight Replacement Areas 3 through 5B and determined that the Mitigated Negative Declaration satisfied the requirements of the California Environmental Quality Act (CEQA)
- **4. July 22, 2019** Board recommended City Council award Bid No. RPU-7656, approve Work Order No. 1718078 for the Wood Streets Streetlight Replacement Project, Phase 3, and adopt the Mitigated Negative Declaration for the Proposed Streetlight Replacements for Areas 3 through 5B Project

BACKGROUND CONT.

- 5. August 6, 2019 City Council adopted the Mitigated Negative Declaration for the Streetlight Replacement for Areas 3 through 5B, awarded the Bid and Approved Work Order No. 1718078 for the Wood Streets Streetlight Replacement Project, Phase 3
- **6. September 12, 2022** Board approved Work Order No. 1904073 for the Wood Streets Streetlight Replacement Project, Phase 4.
- 7. Project to-date
 - a. Total of 811 new streetlight standards have been installed
 - b. New streetlight standard is replica of original historic standard with acorn style luminaire
 - c. New streetlight standard features energy efficient LED (Light Emitting Diode) lamps



SCOPE OF WORK

- Replacement of 175 streetlight standards with new concrete streetlight standards and paving
- 2. Install 21,400 feet of conduit
- 3. Install 24,850 circuit feet of secondary underground cable
- 4. There are no anticipated electric service disruptions as part of this project
- 5. 24 weeks to complete work

RECOMMENDATIONS

That the Board of Public Utilities:

- 1. Award RPU Bid No. 8078 Streetlight Replacement Project, Phase 5, to Herman Weissker, Inc., of Riverside, of Torrence, California, in the amount of \$3,661,859.05;
- 2. Authorize change order authority to the Herman Weissker, Inc., Construction Contract in a not-to-exceed amount of 10%, or \$366,185.91, for RPU Bid No. 8078;
- 3. Approve the capital expenditure for Work Order No. 2208638 in the amount of \$4,200,000 which includes all design, construction, construction support, contract administration, inspection and construction change order authority costs for the Streetlight Replacement Project, Phase 5; and
- 4. Authorize the City Manager, or designee, to execute any documents necessary to effectuate the project described herein, as well as the ability to make minor non-substantive changes in alignment with all purchasing policies.
