

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
3 RIVERSIDE, CALIFORNIA, AMENDING RESOLUTION NO.
4 21052 AND THE MASTER FRINGE BENEFITS AND SALARY
5 PLAN TO APPROVE THE SALARY ADJUSTMENT TO THE
6 CITY ATTORNEY SALARY RANGE AND TO REFLECT
7 REVISIONS TO THE CITY ATTORNEY EMPLOYMENT
8 AGREEMENT.

9 WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council
10 thereby adopting the Master Fringe Benefits and Salary Plan (“FBSP”); and

11 WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;
12 and

13 WHEREAS, the FBSP has been amended several times to update the benefits and
14 salaries; and

15 WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary
16 adjustment to the City Attorney classification; and

17 WHEREAS, changes to the FBSP need to be made to reflect revisions to the deferred
18 compensation contribution for the City Attorney as negotiated in the employment agreement.

19 NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
20 follows:

21 Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are
22 hereby amended to 1) adjust the salary range for the City Attorney classification, as set forth in
23 Exhibit “A” attached hereto and incorporated herein by reference; and 2) reflect the revisions to
24 the City Attorney Employment Agreement, as set forth in Exhibit “B” attached hereto and
25 incorporated herein by reference.

26 Section 2: Authorize the City Manager, or his designee, to make minor, non-
27 substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
28 procedures or documents necessary to implement these provisions.

Section 3: The provisions of this resolution shall be operative upon adoption.
