

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, AUTHORIZING THE APPLICATION AND ACCEPTANCE OF GRANT FUNDS FROM THE FEDERAL AVIATION ADMINISTRATION FOR THE DEVELOPMENT OF AN AIRPORT PAVEMENT MANAGEMENT SYSTEM (APMS) AT THE RIVERSIDE MUNICIPAL AIRPORT; AND AUTHORIZING THE EXECUTION OF ALL NECESSARY DOCUMENTS RELATED TO SUCH GRANT.

WHEREAS, the City of Riverside is committed to promoting continued improvements at the Riverside Municipal Airport, to accommodate increased air traffic and operations; and

WHEREAS, the Federal Aviation Administration ("FAA") may award Federal financial assistance for airport improvement projects called the Airport Improvement Program ("AIP"); and

WHEREAS, in January 2025, the City of Riverside ("City") submitted a grant application to the FAA in the amount of One Hundred Four Thousand Five Hundred Dollars (\$104,500.00) for the development of an Airport Pavement Management System (APMS) at Riverside Municipal Airport ("Project").

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

<u>Section 1</u>. That the City Manager of the City of Riverside, or his designee, on behalf of the City of Riverside, is authorized to submit an application and accept funds from the FAA for the Project.

<u>Section 2</u>. That the City Manager of the City of Riverside, or his designee, is authorized to execute the necessary grant documents and agreements.

<u>Section 3</u>. That the City Council authorize acceptance of FAA grant funds for an account to be assigned by the City's Finance Division for appropriate revenues and expenditures.

<u>Section 4</u>. That the Airport Manager of the City of Riverside is authorized to furnish such additional information as the FAA may require in connection with the application and acceptance of such funding.
