Commission of the Deaf excused the absence of Commissioners Friend and Reynolds from the meeting on September 10, 2025, regular meeting.

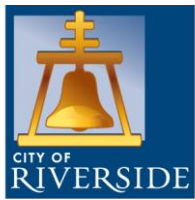
PRESENTATION

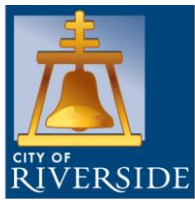
COMMISSION OF THE DEAF STAFF UPDATES
