

First Amendment to the OverDrive Digital Library Reserve Access Agreement

This First Amendment to the OverDrive Digital Library Reserve Order Form and Access Agreement ("First Amendment") is made and entered into on this day of 2025, by and between the City of Riverside, a California charter city and municipal corporation ("City") and OverDrive, Inc., a Delaware corporation authorized to do business in California ("OverDrive").

WHEREAS, on October 11, 2024, City and OverDrive entered into a Digital Library Reserve Order Form and Access Agreement for digital library services ("Agreement"); and the Agreement is set to expire after a term of twelve (12) months, commencing on start of service. The Agreement shall automatically renew for successive terms of twelve (12) months unless either party provides written notice of intention not to renew ninety (90) days prior to the expiration of the then-current term; and

WHEREAS, the total compensation amount under the Agreement is not to exceed One Hundred Seventy-Six Thousand Seven Hundred Sixty-Six Dollars (\$176,766); and

WHEREAS, the parties now seek to amend the Agreement to increase compensation in the approximate amount of eight thousand five hundred dollars (\$8,500);

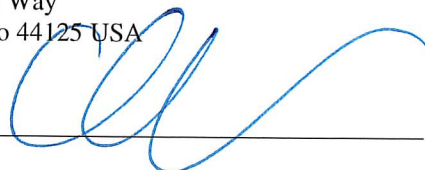
THEREFORE, OverDrive and City agree as follows:

1. The parties agree that the new Contract Price shall not exceed One Hundred eighty-five thousand two hundred sixty six dollars (\$185,266).
2. All terms and conditions of the Agreement not inconsistent with this First Amendment shall remain in full force and effect and are incorporated herein by this reference as thought set forth in full.
