5	EXISTING ADMINISTRATIVE INTERN, CLERICAL ASSISTANT, GENERAL SERVICE WORKER, AND
6 7	TECHNICAL INTERN CLASSIFICATIONS; AND TO REVISE SECTION 7, SICK LEAVE, TO INCORPORATE SENATE BILL 616 REGARDING PAID SICK LEAVE.
8	WHEREAS, on October 4, 2005, Resolution No. 21052 was adopted by the City Council
9	thereby adopting the Master Fringe Benefits and Salary Plan ("FBSP"); and
10	WHEREAS, the FBSP includes the fringe benefits and salary plans for City employees;
11	and
12	WHEREAS, the FBSP has been amended several times to update the benefits and
13	salaries; and
14	WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the 2024 State
15	mandated increase to the minimum wage; and
16	WHEREAS, the Job Code Table of the FBSP needs to be revised to reflect the salary
17	adjustments to the existing Administrative Intern, Clerical Assistant, General Service Worker,
18	and Technical Intern classifications; and
19	WHEREAS, the FBSP, Section 7, Sick Leave, needs to be revised to incorporate Senate
20	Bill 616 Paid Sick Leave for all working Californians.
21	NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, as
22	follows:
23 24	Section 1: Resolution No. 21052 and the Master Fringe Benefits and Salary Plan are
24 25	hereby amended to 1) reflect the 2024 State mandated increase to the minimum wage; 2) approve
23 26	the salary adjustments to the existing Administrative Intern, Clerical Assistant, General Service
20	Worker, and Technical Intern classifications, all as set forth in Exhibit "A" attached hereto and
28	incorporated herein by reference; and 3) approve the amendment to Section 7, Sick Leave, to

1	incorporate Senate Bill 616 Paid Sick Leave for all working Californians, as set forth in Exhibit
2	"B" attached hereto and incorporated herein by reference.
3	Section 2: Authorize the City Manager, or his designee, to make minor, non-
4	substantive changes to the Master Fringe Benefits and Salary Plan and any related policies,
5	procedures or documents necessary to implement these provisions.
6	Section 3: The provisions of this resolution shall be operative upon adoption.
