

SECOND AMENDMENT TO
PROFESSIONAL CONSULTANT SERVICES AGREEMENT

THIS SECOND AMENDMENT TO PROFESSIONAL CONSULTANT SERVICES AGREEMENT (“Second Amendment”) is made and entered into this _____ day of _____, _____, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation (“City”), and THE SUPERLATIVE GROUP, INC., an Ohio corporation authorized to do business in California (“Consultant”), with respect to the following:

RECITALS

WHEREAS, the City and Consultant entered into that certain Professional Consultant Services Agreement dated March 23, 2023, for Sponsorship Asset Inventory Evaluation, Valuation, Naming Rights, and Sales (“Agreement”) and expiring on March 23, 2025; and

WHEREAS, on or about April 2, 2025, the parties entered into a First Amendment to Professional Consultant Services Agreement to extend the Term of the Agreement to allow Consultant sufficient time to perform Phase II Program Implementation and Phase III Transition Plan services, to December 31, 2025; and

WHEREAS, City and Consultant now desire to extend the Term of the Agreement, from December 31, 2025, to December 31, 2026, to allow Consultant sufficient time to perform Phase II Program Implementation and Phase III Transition Plan services.

NOW, THEREFORE, in light of the foregoing recitals, which are incorporated herein by this reference, City and Consultant hereby agree as follows:

1. The Parties agree that the Phase II Term commenced on February 1, 2024, and expired on February 1, 2025. The Parties further agree that the Phase III Term commenced on February 1, 2025, and, unless extended or sooner terminated, shall expire on December 31, 2026. Notwithstanding anything in the Agreement to the contrary, as of January 1, 2026, the City’s obligation to pay Retainer payments for Services to be performed after January 1, 2026, shall cease.

2. All terms and conditions of the Agreement not inconsistent herewith, shall remain in full force and effect and are hereby incorporated by reference into this Second Amendment as though set forth in full herein.
