

- 2025 Workplans began on March 1, 2025, and conclude on February 28, 2026.







  - Demolition of 4472 Orange Grove





- Adopted February 19, 2025.




# 2025 WORKPLAN UPDATE

- Scheduled to be complete April 2026




# 2025 WORKPLAN UPDATE

- January 21, 2026 – Fairmount Park Master Plan update








