1. Established of axle restriction on Trautwein between Alessandro and Van Buren
2. Caltrans- Grant application for a design plan for pedestrian/bikeway bridge over the 91 Fwy

#### **Traffic Engineer Updates**

1. Consider Changing the time of board meetings the third Wednesday of the month at 6 p.m. did not receive adequate support.
2. The installation of the “No Left Turn” time limited restriction sign on Mission Inn and Redwood on both East/Westbound has resulted in zero left turn collisions since the installation in January.
3. Grant received for Affordable Housing and Sustainable Community worth \$30 Million. Only 750k is going to Traffic and Transportation improvement projects. About \$6 Million will be going toward the construction of the sidewalks.

4. The City-wide Safe Route to School project will provide an individualized pedestrian and bicycle circulation plan for each of the fifty (50) elementary and middle schools, promoting walking and biking to school to alleviate cars driving to schools.
5. Public outreach meeting on December 14, 2023, for the VMT Mitigation Project Program.
6. Provided an update on the two (2) Transportation Board Members vacancies.
7. Abernathy & Perthshire - Temporary Cul-De-Sac Pilot Project implemented in May. Providing a long-term solution to the City Council on January 16, 2024.
8. Mariposa Alley Project Update – Currently a pilot project but will move forward to make that a permanent improvement.
