4	FROM THE U.S. DEPARTMENT OF HOMELAND SECURITY THROUGH THE CALIFORNIA OFFICE OF EMERGENCY
5	SERVICES FOR THE FISCAL YEAR 2022 STATE HOMELAND SECURITY PROGRAM GRANT (SHSP), WHICH INCLUDES THE
6	COUNTYWIDE HAZMAT OPERATION GROUP (CHOG) PROGRAM, AND AUTHORIZING THE EXECUTION OF ALL DECUMENTS BY THE CITY MANAGER OF HIS
7	REQUIRED DOCUMENTS BY THE CITY MANAGER OR HIS DESIGNEE; AND AMENDING THE BUDGET FOR FISCAL YEAR 2022-2023 ACCORDINGLY.
8	TEAR 2022-2025 ACCORDINGET.
9	WHEREAS, the U.S. Department of Homeland Security (the "Grantor") has been delegated
10	authority to award federal financial assistance for the Fiscal Year 2022 State Homeland Security
11	Program Grant (SHSP); and
12	WHEREAS, the federal funds have been sub-granted to the California Office of Emergency
13	Services; and
14	WHEREAS, the County of Riverside is the designated Operational Area to which California
15	Office of Emergency Services grant funds are awarded and distributed; and
16	WHEREAS, the City desires to apply for and upon grant award, accept the grant award from
17	the Department of Homeland Security up to the amount of \$62,000; and
18	WHEREAS, the City Council desires to amend the annual budget of the City to reflect and
19	incorporate the Grant so awarded to the City, and to increase the annual appropriations and
20	expenditures in the appropriate City program to reflect such award.
21	NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside,
22	California, as follows:
23	Section 1: The City Manager, or his designee, are hereby authorized to submit a grant
24	application for and on behalf of the City of Riverside, through the County of Riverside, and are
25	hereby authorized to execute all actions necessary for the purpose of obtaining federal financial
26	assistance provided by the United States Department of Homeland Security and sub-granted through
27	the State of California, including any extensions and amendments thereof.

1	Section 2: The City Council of the City of Riverside hereby agrees to, and by this Resolution
2	does, accept the Grant funds up to the amount of \$62,000 awarded to the City of Riverside.
3	Section 3: The City of Riverside hereby agrees to comply with each and all of the terms,
4	conditions, and limitations, imposed by the Grantor upon said Grant. The City Manager, or his or her
5	designee, is hereby authorized and directed to execute the Signature Authority document as well as
6	any agreements, assurance, or other documents as may be necessary in connection with acceptance
7	and implementation of said Grant as may be required by the Grantor.
8	Section 4: The annual budget of the City of Riverside for fiscal year 2022-2023 is hereby
9	amended by increasing the appropriations and authorized expenditures in such amount as is equal to
10	the amount of Grant funds to be received by the City.
