

1 RESOLUTION NO.

2 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE,
3 CALIFORNIA, AUTHORIZING SUBMITTAL OF APPLICATION(S) FOR
4 ALL CALRECYCLE GRANTS FOR WHICH CITY OF RIVERSIDE IS
5 ELIGIBLE.

6 WHEREAS, Public Resources Code sections 48000 *set seq.* authorize the Department of
7 Resources Recycling and Recovery (“CalRecycle”) to administer various grant programs (“Grants”)
8 in furtherance of the State of California’s (“State”) efforts to reduce, recycle and reuse solid waste
9 generated in the State thereby preserving landfill capacity and protecting public health and safety and
10 the environment; and

11 WHEREAS, in furtherance of this authority CalRecycle is required to establish procedures
12 governing the application, awarding, and management of the Grants; and

13 WHEREAS, CalRecycle grant application procedures require, among other things, an
14 applicant’s governing body to declare by resolution certain authorizations related to the administration
15 of CalRecycle Grants.

16 NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Riverside,
17 California, authorizes the submittal of application(s) to CalRecycle for the 7th Cycle (ORG7) Fiscal
18 Year 2021-2022 and 2022-2023 Organics Grant Program Funding;and

19 BE IT FURTHER RESOLVED that the City Manager, or his designee, is hereby authorized
20 and empowered to execute in the name of the City of Riverside all grant documents, including but not
21 limited to, applications, agreements, amendments and requests for payment, necessary to secure grant
22 funds and implement the approved grant project; and

23 BE IT FURTHER RESOLVED that these authorizations are effective for five (5) years from
24 the date of adoption of this resolution.
