## **BACKGROUND**

- June 2, 2020, the City Council adopted the 2020-2021 U.S.
   Department of Housing and Urban Development Annual Action
   Plan to allocate \$300,000 for the rehabilitation of a duplex located
   at 2348 University Avenue
- Substantial rehabilitation of a duplex to address health and safety issues, including the foundation, carpentry, roofing, windows, drywall, HVAC, electrical, plumbing, ADA accessibility, landscape, and fire suppression

## **DISCUSSION**

- 1. Reassessed 2348 University Avenue rehabilitation project after lead-based paint and asbestos report
- 2. Each project options cost approximately \$1,200,000
  - a. Substantially rehabilitation duplex
  - b. Demolish existing duplex and develop three affordable housing units
    - a. Construction of new housing is not an eligible CDBG activity

## REPROGRAMMING OF FUNDS

- Reallocate \$300,000 of CDBG funds from 2348
   University Avenue to the Riverside Access Center Rehabilitation Project that is located within incomeeligible Census Tract 305.02 Block Group No. 2
- 2. Total CDBG project allocation: \$961,000

## **RECOMMENDATIONS**

#### That the City Council:

- 1. Authorize an amendment to the 2020-2021 United States Department of Housing and Urban Development Annual Action Plan to cancel the 2348 University Avenue Housing Rehabilitation Project and its allocation of \$300,000;
- 2. Authorize a funds transfer in the amount of \$300,000 within the Development Grants Fund from the 2020-2021 2348 University Avenue Housing Rehabilitation account to the 2023-2024 Riverside Access Center Rehabilitation account:
- 3. Authorize an amendment to the 2023-2024 United States Department of Housing and Urban Development Annual Action Plan to reprogram \$300,000 to the Riverside Access Center Rehabilitation Project;

## **RECOMMENDATIONS**

- 4. Authorize the City Manager, or his designee, to execute a Memorandum of Understanding with the Department of Housing and Human Services Department for the 2023-2024 Riverside Access Center Rehabilitation Project, including making minor non-substantive changes, and to sign all documents and instruments necessary to implement this action; and
- 5. Upon execution of the Memorandum of Understanding, authorize the supplemental appropriation of \$300,000 to Grants and Restricted Programs Fund project accounts to be assigned by the Finance Division, and a supplemental appropriation in the same amount to the inter-fund account for reimbursement of CDBG-related expenditures.
