- SUBJECT: RENEWAL OF PROOFPOINT FROM CDW-G FOR A CYBERSECURITY SOLUTION WITH A TWO-YEAR TERM ENDING APRIL 19, 2026, IN THE AMOUNT OF \$108,969

#### ISSUE:

Authorize the renewal of Proofpoint from CDW-G of Chicago, Illinois, for a cybersecurity solution, under OMNIA Cooperative Purchasing Agreement No. 23-6692-02, with a two-year term ending April 19, 2026, in the amount of \$108,969.

#### **RECOMMENDATIONS:**

That the City Council authorize the renewal of Proofpoint from CDW-G of Chicago, Illinois, for a cybersecurity solution, under OMNIA Cooperative Purchasing Agreement No. 23-6692-02, with a two-year term ending April 19, 2026, in the amount of \$108,969.

### BACKGROUND:

Companies of all sizes face an increasing risk of cyberattacks. These attacks often target employees through familiar channels like email, social media, and mobile devices to access sensitive information or steal money. The goal of these attacks can be to disrupt business, gain access to valuable data, or hold a company's systems hostage for a ransom.

Proofpoint is a cybersecurity company that provides advanced protection for businesses. They specialize in defending against attacks that target a company's employees and their digital information. Proofpoint's tools and expertise are designed to detect and block these threats, often before they can infiltrate a company's network. Proofpoint's success is reflected in its widespread adoption. It is used by a significant portion of the world's largest companies, including major banks, retailers, pharmaceutical leaders, and top research universities.

#### DISCUSSION:

Originally purchased in 2023, renewal of the Proofpoint software subscription will allow the Innovation and Technology Department to continue the use of Proofpoint to help detect and block

advanced threats and compliance risks by applying it to email, data loss prevention, electronic discovery, electronic archiving, identity threats and more.

This cooperative agreement is in line with the City's Purchasing Resolution No. 24101, Sections 602(f) and 702(u).

Purchasing Resolution No. 24101 Section 602 states, "Competitive Procurement through the Informal Procurement and Formal Procurement process shall not be required in any of the following circumstances: ...(f) When Cooperative Purchasing is available and undertaken or when Goods can be obtained through Federal, State and/or other public entity pricing contracts or price agreements."

Purchasing Resolution No. 24101 Section 702 states, "Competitive Procurement through the Informal Procurement and Formal Procurement process shall not be required in any of the following circumstances: ...(u) When the Procurement is for the renewal of maintenance, license(s), support, or a similar need for existing technology systems, including hardware, and the items are procured from a vendor/reseller that was originally selected based on the City's procurement standards, provided that 1) the vendor has been used consecutively since then and 2) if there are any non-substantive changes to the procurement, the Manager is satisfied that the best price, terms and conditions have been negotiated."

The Purchasing Manager concurs that the recommendations to authorize the purchase comply with Purchasing Resolution 24101, Sections 602(f) and 702(u).
