RECITALS

- A. The City and Consultant entered into that certain Professional Consultant Services Agreement dated March 26, 2019 ("Agreement"), for Internet Service Provider (RFP No. 1841), which expires on November 30, 2021.
- B. The City and Consultant desire to extend the term of the Agreement to March 31, 2024, and add additional compensation at the Year 4 and Year 5 amount of One Thousand Eight Hundred Dollars per year, for a total of Three Thousand Six Hundred Dollars (\$3,600.00), during the extended term of the Agreement.

NOW, THEREFORE, incorporating the recitals set out above, the parties hereto mutually agree to the following amendment to the Agreement.

- 1. Section 2, Term, is hereby amended to extend the term of the Agreement to March 31, 2024, and add additional compensation at the Year 4 and Year 5 amount of One Thousand Eight Hundred Dollars per year, for a total of Three Thousand Six Hundred Dollars (\$3,600.00), during the extended term of the Agreement.
- 2. All other terms and conditions of the Agreement between the parties, which are not inconsistent with the terms of this First Amendment, shall remain in full force and effect as if fully set forth herein.
