

- 4292 Cedar Street
- 3 affordable housing units – Duplex and ADU
- Building permits have been issued
- Project to be completed by December 2023

# EASTSIDE CLIMATE COLLABORATIVE

CITY OF RIVERSIDE

- Close to 700 shade trees planted and 268 trees have been provided to residents to plant at homes
- Construction workforce cohort: New trainer has been procured and recruitment is in progress
  - Combined event with Workforce Development Department is being planned
- Xeriscaping program: Received 14 applications, which six have been approved
- Solar Installations: Received 13 applications, 2 solar installations have been completed
- Gen Farmer Training held on April 17th
- Town Hall with County Workforce Development job fair held April 26th
