SUBJECT: INTRODUCE AND SUBSEQUENTLY ADOPT AN ORDINANCE OF THE CITY OF

RIVERSIDE, CALIFORNIA, UPDATING SECTIONS OF TITLE 12 OF THE

RIVERSIDE MUNICIPAL CODE - AIRPORT RULES AND REGULATIONS

ISSUE:

Introduce and subsequently adopt an Ordinance of the City of Riverside, California, updating sections of Title 12 of the Riverside Municipal Code – Airport Rules and Regulations.

RECOMMENDATIONS:

That the City Council Adopt an Ordinance of the City of Riverside, California, updating sections of Title 12 of the Riverside Municipal Code – Airport Rules and Regulations.

COMMISSION RECOMMENDATION:

On December 14, 2023, the Airport Commission reviewed and supported the updates to Title 12 of the City of Riverside Municipal Code – Airport Rules and Regulations.

BACKGROUND:

On January 23, 2024, the City Council considered an update to Title 12 of the City of Riverside Municipal Code – Airport Rules and Regulations.

Title 12 of Riverside Municipal Code, Airport Rules and Regulations, requires periodic updating. Several revisions to Title 12 are proposed to address the creation of various airport policies, regulation of off-airport commercial vendors, airworthy aircraft, and vehicle speed limits.

DISCUSSION:

Title 12 Revision. Revised language is underlined.

- 12.01.010 Rules and regulations adopted Airport Manager defined.
 - "...shall obey all applicable rules and regulations herein <u>and policies</u> as established and adopted as may be revised periodically."
- 12.04.060 Commercial and business activities require permits and licenses.
 - "Commercial vendors not based at the Airport must comply with the commercial airport vendors policy."
- 12.04.120 Motor vehicle regulations.
 - B. "...in excess of posted speed traffic signs and in no event in excess of <u>15</u> miles per hour. "Near aircraft, the maximum speed shall not exceed 5 miles per hour."
- 12.04.150 Use of hangars.
 - C. <u>"Aircraft must be maintained in an airworthy condition with current annual inspections.</u> Any person renting a hangar containing an aircraft that is not airworthy or who intends to restore...."

STRATEGIC PLAN ALIGNMENT:

This revision to Title 12 aligns with Strategic Priority No. 5 High Performing Government.

This item aligns with EACH of the five Cross-Cutting Threads as follows:

- 1. **Community Trust** By maintaining Rules and Regulations that ensure a safe and secure airport, community trust is bolstered.
- 2. **Equity** Equitable use of the airport is supported by up-to-date Rules and Regulations.
- 3. **Fiscal Responsibility** Fiscal responsibility is supported by up-to-date Rules and Regulations.
- 4. **Innovation** Continuous innovation requires periodic updating of Airport Rules and Regulations. As new airport polices are developed, Title 12 may require updating as well.
- 5. **Sustainability and Resiliency** Title 12 supports a safe and secure airport that supports airport resiliency and sustainability.

FISCAL IMPACT:

There is no fiscal impact associated with the proposed update to Title 12 of the City of Riverside Municipal Code – Airport Rules and Regulations.
