## **BACKGROUND**

- 1. Riverside Energy Resource Center (RERC)**
  - a. Four General Electric (GE) LM6000 model gas turbine engines
  - b. Provide 30% of Riverside's summer daily electric power demands
- 2. GE issued Service Bulletin 310 (February 2016)**
  - a. Partial Turbine blade replacement after 1500 turbine start-ups
  - b. Potential catastrophic failure if replacement not completed
- 3. RERC 1&2**
  - a. Completed in 2016 for first time
  - b. Reached an additional 1500 starts since that time and ready for replacement again

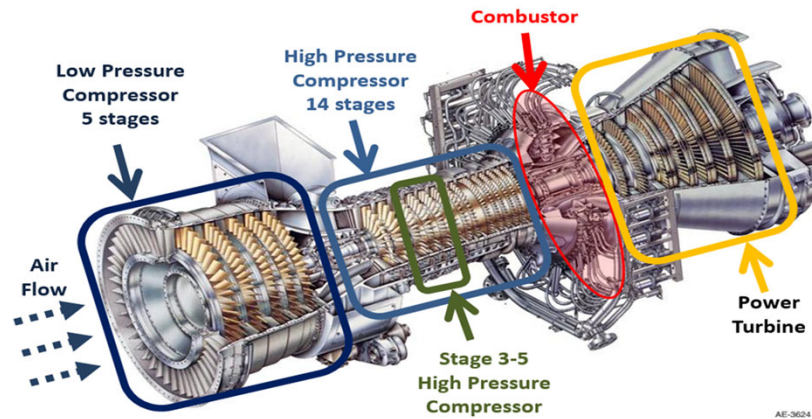

  - b. One proposal received from GE Package Power, LLC
2. GE Packaged Power, LLC proposal
  - a. Competitive pricing
  - b. OEM and meets Riverside's scheduling requirements
