

**SEVENTH AMENDMENT TO SOFTWARE LICENSE AND HARDWARE
MAINTENANCE AND SUPPORT AGREEMENT FOR UPLINK SOLUTION**

**(Software License and Hardware Maintenance and Support Agreement
for Uplink Solution)**

THIS SEVENTH AMENDMENT TO SOFTWARE LICENSE AND HARDWARE MAINTENANCE AND SUPPORT AGREEMENT FOR UPLINK SOLUTION (“Amendment”) is made and entered into this ____ day of _____, 2023, by and between the CITY OF RIVERSIDE, a California charter city and municipal corporation, and LIVEU, INC., a Delaware corporation duly authorized to do business in California, with its principal offices at 2 University Plaza Drive, Hackensack, NJ 07601 (“LiveU”) as described below.

RECITALS

WHEREAS, on or about September 14, 2011, the City and LiveU entered into a Lease Agreement for the rental of hardware and software equipment (as referenced above, the “Agreement”). The Agreement was subsequently renamed from “Lease Agreement for Rental of Software and Hardware Equipment Agreement for Uplink Solution” to “Software License and Hardware Maintenance and Support Agreement for Uplink Solution”;

WHEREAS, on or about June 1, 2014, Customer and LiveU entered into a First Amendment to the Agreement;

WHEREAS, on or about April 1, 2016, Customer and LiveU entered into a Second Amendment to the Agreement;

WHEREAS, on or about August 15, 2017, Customer issued Purchase Order No. 180252 to continue and renew the Agreement terms, and parties thereafter deemed Purchase Order No. 180252 as equivalent to a third amendment to the Agreement;

WHEREAS, on or about April 1, 2018, Customer and LiveU entered into a Fourth Amendment to the Agreement;

WHEREAS, on or about October 1, 2020, Customer and LiveU entered into a Fifth Amendment to the Agreement;

WHEREAS, on or about October 27, 2021, Customer and LiveU entered into a Sixth Amendment to the Agreement;

WHEREAS, the City continues to need and use the goods and services provided under the Agreement; and

WHEREAS, the City desires to continue to receive and utilize, and LiveU desires to provide, the services under the Agreement.

The parties hereby agree as follows:

1. **Term.** The term of the Agreement is hereby extended to June 30, 2026.
2. **Compensation.** Annual compensation shall not exceed Eighteen Thousand One Hundred Sixty Two Dollars (\$18,162.00) for each year of the extended term of the Agreement, in accord with the quotation attached hereto as Exhibit A-1 and incorporated herein by this reference.
3. Except as amended by this Amendment, all terms under the Agreement remain unchanged and in full force and effect.

IN WITNESS WHEREOF, Customer and LiveU have caused this Seventh Amendment to Software License And Hardware Maintenance And Support Agreement For Uplink Solution to be duly executed and effective as of the date written above.

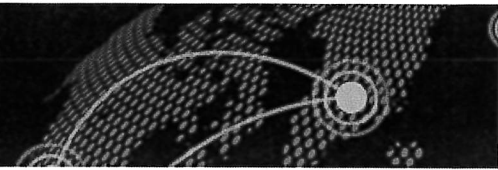
